> Governor Kitchen of North Carolina says; "Prohibition has now been in force throughout the state for two years. This is a short period with which to measure the effects of a reform movement. We have done little more than planted the seed, whose full fruitage will be gathered by coming generations. And yet already the results fully justify its adoption. There has been, as appears from the Attorney General's report, based upon Superior Court crime, even in the crime of violating the prohibition law.
