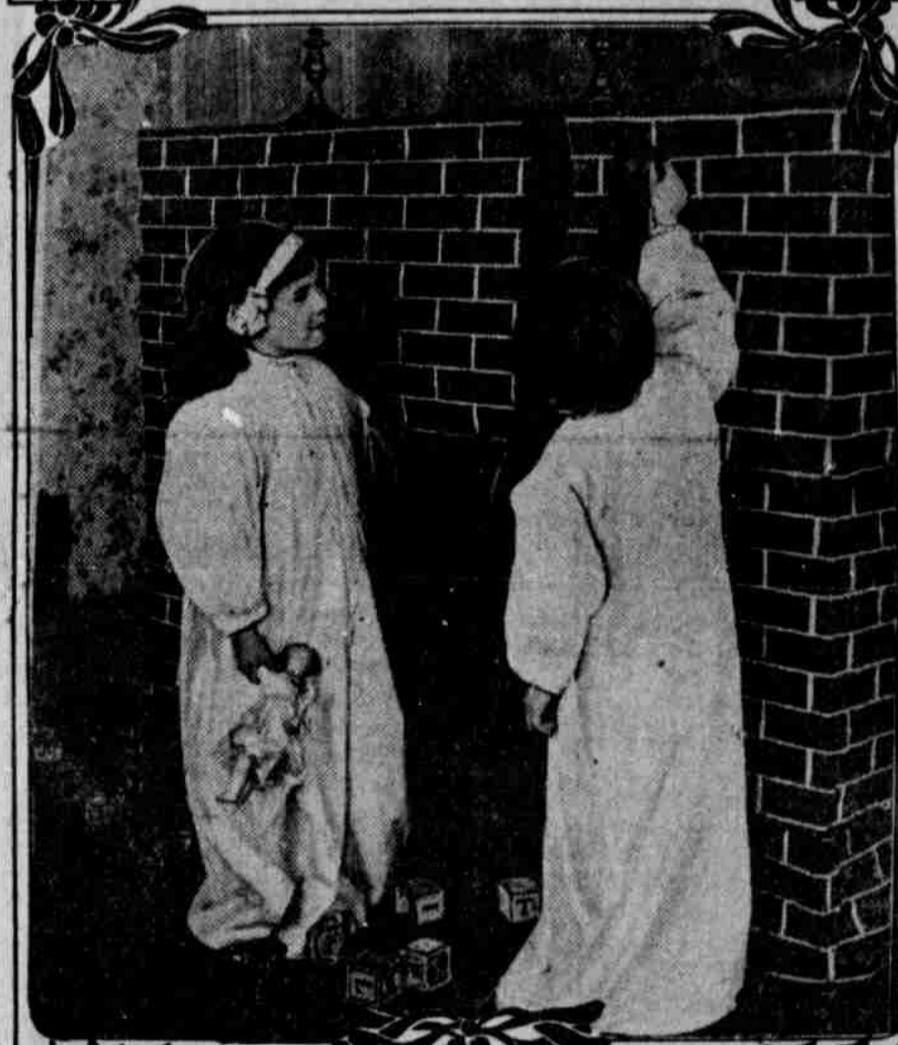
THE THREE AGES OF CHRISTMAS.
