The Chicago headquarters of the Burlington railroad has sent out letters to all agents on its lines calling attention to the seriousness of the fessor's signal. Mars is either too freight car shortage and urging that people secure their winter's supply of coal without delay in order to forestall a serious shortage this winter.

> The letters point out that the movement of the grain crops and the shipment of live stock for the next 90 days make it impossible to assign more cars for coal shipments. It urges dealers particularly to accept their shipments for lighit territory in open box cars, rather than depend on enclosed cars as a means of insuring quicker delivery.

The letters conclude with the following statement: "We hope you can pr. ail on all concerned to have coal ordered and shipped out without further delay to avoid a serious shortage during the winter months."

FLY IN THE OINTMENT DOES CONSUNER SEE THE PRICE?

> On August 10th a Scottsbluff county shipper on the Omaha markets received \$32 for four calves, or 200 pounds and-the price paid being 4c per pound. On the same day the price of dressed veal, paid by Scottsbluff dealers was from 15c to 16c per pound, not counting the freight. Thus between the producer and the retailer there was a difference of 12c per pound, and between the producer and the consumer the 12c, the freight and the added price the retailer was obliged to tack on in order t omaintain his own business and exist, says the Scottsbluff Star-

Herald. According to an account of the sales of Jacob Grof of Morrill, on a shipment of 25 head made on the above date, he received 3 1-4c per beef was sold to the dealers in of 12 3-4c per pound between the producer and the dealer to say nothing of the consumer.

It certainly could not be reasonbasket, hundreds of the unwary plac-3 1-4c per pound was paid the producer was sold at the 16c rate, but even making allowance between the canners and the prime, it rather staggers the reason to imagine the necessity of the profit thus taken by the packers, who, according to their own admission-"do not fix the price but who allow the public to do that by the demand for meat."

Any resident of Scottsbluff or any other city who desired the producer to receive 3 1-4c per pound for beef, please stand up. Any consumer of Scottsbluff who is in favor of the dealer being forced to pay 16c per pound will also please make himself known. In the absence of such testimony, it will be concluded that the Big Five have prevaricated.

A perusal of the sales record, in addition to the prices quoted above show that the Morrill man received 6 1-2s as the highest price for a yearling steer, which weighed 640 pounds, seven heifers brought 6c. others 5c and the calves and cows are quoted above. The entire amount received for the 25 head was \$666.87 from which was deducted freight, feed, commission, etc., of \$119.44. making the net return on the shipment \$547.43 on a bunch of cattle that had consumed over \$1,000 worth of feed.
