Rafael Anchelor, a prominent politician, who had twice held office, was re-elected by a few votes after a most exciting con test. Anchelor was distasteful on ac-count of his efforts to inaugurate reforms, and threats were openly made against his life. Signs of trouble were manifest all day, but little or no attention was paid to them by the officials. About 4 o'clock in the afternoon a mob of over two hundred men suddenly appeared in the streets and at once surrounded the city building. Without warning they opened fire with shot guns and pistols on the people. Anchelor was instantly killed. The mob then took possession of the town, but not without a hard fight between them and the friends of Anchelor. During the battl three revolutionists were killed and many on both sides fatally wounded. Franco Sanzo, one of the leaders of the mob was among those killed. The impression prevails here that this is a movement in support of Garza, but Juan De Matta Vasques, second in command of the Mexican custom house guards on the border, expressed the pinion that the disturbance is purely local and will soon be suppressed. So or Pasalgua, the Mexican consul here has gone to Juarez in order to be in immediate communication with his government. Troops are reported to be hastening from Chihuahua to the point of outbreak. In the meanwhile the town is in possession of the mob and the town is in possession of the mob and further bloodshed is expected.

Garza's Movements. San Antonio, Jan. 11.—There is much

peculation as to the next movement of the Garza revolutionists. That they are reorganizing on Texas soil and dividing nto numerous bands with some object in view there remains no longer any doubt. The United States troots will continue in the field as long as there is any indication of the neutrality laws being violated, and they will continue to spend the 'me in searching for the Garza gang, as they have been doing for the Garza gang, as they have been doing for the past two weeks. The proposition of Mexican Minister Romero that there has international agreement made whereby United States troops may be permitted to cross into Mexico in pursuit of the offenders and visco in pursuit of the offenders and vice versa, is not we received by the military officers of this department. They assert that the soldiers of that country would be glad of an opportunity to shoot down and pluder United States troops, and that even the officers would encourage and assist in committing the outrages. in committing the outrages.

this side of the border, for the present at least. He states that he feels assured that they will not attack the government troops unless cornered, and in that event he places confidence in the fighting abil-

Chase, who was to have reached the Palito Blanco ranch, seventeen miles southeast of San Diego, at which place the Mexican authorities and General Lorenzo Garcia particular-ly, claim that Garza has his headquarters. Captain Chase has instruc-tions to make a thorough search of the ranch, and the result of the expedition is awaited with much interest and of no little anxiety at department headquarters here. General Uprising Threatened.

SAN ANTONIO, Jan. 11.—The startling information was brought here by J. C. Godfrey from Peidras Negras, Mexico, that there is a general uprising threat-ened in the states of Durango, Chihua-hua, Coahuila and Sonora, and that the hua, Coahula and Sonora, and that the malcontents are well organized and will flock to the standard of Garza. He states that in parts of Chihuahua the poorer classes have already revolted and are marching in bands of from three to four hundred across the country, committing depredations.
