Church Howe Promoted

Hon. Church Howe, of this city, who is now serving as consul-general to Montreal, Canada, received word from Washington, D. C., the first of the week, to the effect that he had been promoted to the position of consulgeneral to Manchester, England, one of the largest as well as one of the most important industrial and commercial points in the world.

Before relinquishing his office at Montreal he has been granted sixty days leave of absence. From Montreal he will go to Hot Springs, Arkansas, where he will take the baths for relief of a slight touch of rheumatism, for twenty days. He will then come to this city and will visit his friends and relatives here for forty days, when he will sail to England and take charge of his post at Manchester.

The rise of Hon. Church Howe in the consular service of the country has been phenomenal.

Since entering the service, being first stationed at Palermo, Sicily, he has served successively at Sheffiield, Antwarp, Belgium: Montreal, Canada, and now goes to Manchester.

In each place he made a profoundly favorable impression with the men with whom he came in contact and was made honorary as well as active member of the most exclusive social clubs of those important cities. He succeeded in establishing for his government, with the citizens and the interests he had to deal, the most cordial relations, and his work has been pro-

ductive of wonderful good to the nation at large in various places in which he has served.
