

Next Tuesday we have our first primary under the new law. The election board that served last Novemper will act on that occasion. The polls will be open at 12 o'clock noon and remain open until 9 o'clock p. m. Each party will have a separate ticket. The same rules governing regular elections will govern this primary election.

While in session on Tuesday last the county commissioners divided the county into ten road supervisor districts under the new law. Peru and Islatd constitute one district, Brownville and London another, and Aspinwall and St. Deroin another, while the seven precincts of Nemaha City, Glen Rock, Douglas, Bedford, Benton, Washington and Lafayette each constitute a district. - Granger.
