Short on Cash. here is nothing more gratifying tate of Nebraska than the marvelous strides being made in the development of the State University in the past two years. The growth of this institution, now the leader of its class in the west, has been remarkably rapid since the beginof the present decade. The biol report of the Board of Reents submitted to the governor two years ago shows that there were 460 students actually in attendance. This did not include private students who simply took instruction in music and art. The biennial report, which went to Governor Boyd Saturday, shows that the actual attendance at the present time is 929. The increase is in all the departments of the university. The regents express their belief that within the two coming years the number of students in actual attendance will have increased to 1,500, and an attendance of 2,000 is within the possibilities of the next four years. With these expectations realized, the state will be confronted with a grave responsibility in the way of furnishing the means to carry on the work in all of the de-

partments. The following paragraph from the report will indicate the extent of the esponsibility which devolves upon re legislature in caring for the SHE REFUSES TO TALK. miversity:

"The unexpected growth in numers has not been accompanied by an equal growth in revenues. It was supposed at the time the threeeighths of a mill tax was granted that the assessment roll of the state would rise with sufficient rapidity to furnish all the funds necessary for university purposes. 



Laying the Corner Stone.

The Sunday's Lincoln Journal ontained the following telegram fated at Elmwood:

"The corner stone of the new Hobbs opera house was laid Saturday with imposing ceremonies. The whole matter, by the way, was complete surprise to the worthy doctor, whose innate modesty would have prompted him to let the matter go by without notice; but not so the enterprising citizens of Elmwood. Charles Rivett, the master mason in charge of the building, very carefully and secretly, so far as the doctor was concerned, prepared a suitable stone, and this afternoon, when the farmers and their families began coming into town, the doctor was anxious to know the reason. At a given signal the Elmwood silver cornet band sturck up one of its liveliest airs and the people assembled at the corner. The doctor and his wife were sent for and Mrs. Hobbs placed the stone in position amidst the cheers of the crowd. Postmaster Cyrus Alton, the former preacher, who has lived side by side with the doctor for the past twenty-two years, made one of his characteristic addreses replete with wit, humor and pathos.
