Further signs are being made to preserve historic structures, save the residence of the Emperor Napoleon, from falling into the hands of some Nineteenth century vandals, who would probably demolish it in order to raise "jerry built" buildings on its site. The old palace is in a rather bad condition, being destitute of furniture, tapestry and paper ornamentation. The two facades—main and courtyard and the other of the garden—are in a tolerably good condition, as well as the windows, staircases and passages.

The rooms here are ready to be rearranged in their old style. The vast porch, the dining room, with its figures of nymphs, marble floor and fountain, the council chamber shaped like a military tent, the library, the salon of the Empress Josephine, with the bedroom attached, are in a fair state of preservation. Malmaison park has already been cut up for building lots, and several small houses with gardens now exist on the property.

The place was purchased in September, 1838, by Josephine, for \$3,000—paid partly out of her marriage portion and partly out of the military allowance of her husband, then General Bernaparte. When First Consul Napoleon spent his leisure hours at Malmaison, and in the early days of the First Empire, the place was for Josephine's has the Petit Train-on was for Marie Antoinette—an agreeable change from palatial splendor. After the death of Josephine, in May, 1814, Malmaison had no occupants of note until Napoleon returned there for a few days before his last exile.

Princes Eugene & Bernhartina looked after the property during his lifetime, but in 1826 his heirs sold it to a Swedish banker. In 1841 Queen Maria Christina of Spain bought it and sold it in 1861 for \$44,000 to the Emperor Napoleon III, who made a present of it to the state. Under the third republic Malmaison has been neglected and allowed to lapse into its present deplorable condition. It was sold to private persons and now awaits other owners.—London Telegraph.

Dogs Testifying in Court. "Hold up your right hand and be sworn," said Judge Tyrrell, addressing Hector, a large mastiff, in court in Cincinnati. The dog had been summoned as a witness, and in compliance with the magistrate's demand Hector held up his right forepaw and commenced barking.

Jean Galade, an anchorite of the Nineteenth century, who has been arrested near Perpignan, can hardly be classed among the disciples of St. Anthony, or of any other pious tenant of the Thebaid. While supposed to be leading a contemplative life he was going about the country stealing like a gypsy. His depredations having been brought to the notice of the proper authorities, the gendarmes were sent out after Jean, and he was captured at St. Paul. The gypsy was promptly placed upon his wrists, and he was marched between two stern faced men to the prison of Prades, where he will remain in real seclusion from the world for a considerable period.—Paris Cor. London Telegraph.

Buried in His Own Coffin. The late Earl of Essex was buried in a coffin of old designed twelve years ago by the deceased nobleman himself, who was a prominent member of the Funeral Reform association. It had what is called "open trellis work" around it and was filled with choice herbs and evergreens. There have been many people of recent years, none of them prominent in other ways, who have had their coffins made to order long before the approach of death. Maybe the originator of the fashion was Lord Nelson, who used to keep standing upright in the coffin of the Victory a coffin that an admiral had presented to him on his birthday anniversary, and in this coffin his lordship's remains were at last put to rest.—Philadelphia Bulletin.
