STATE AND TAXES.

The bugbear, and the principal ob School jection to State organization, in this Territory, is "fear of increased taxation." Let men look with unprejudic d mind upon this question, and let them bear in mind that every mile of Gen. fund 1865 at 2 1 2 mls. \$108 14 railroad built gives us 3,200 acres of School land, and at the minimum Government price of \$1,25 per acre \$4000, while the road proper is estimated in all other States to be worth \$50,000 per mile including rolling stock, machine General fund at 2 1-2 mills shops, Depots, and Way-stations, &c. Sinking do 1 1-2 do We put these figures very low, so that our readers may understand that there is no desire whatever to blind or decieve them. Thus we have for each mile \$54,000, and before the Legislature Gen. fund 1865 at 2 1 2 mls. \$700 12 could meet, on the 4th day of July next, Sinking do 11-2 do there will be one hundred miles of road finished; giving an amount of property subject to taxation of \$5,400,-000, which at a tax of nine mills on the dollar would yield a revenue of General fund at 2 1-2 mls \$29,160. In one year from the meeting of our first Legislature, anether one hundred miles would be completed, and then the aggregate capital of the Union Pacific Railroad subject to taxa tion would be doubled, as would also be the revenue, which alone would be School more than sufficient to defray all the expenses of State Government. Let every citizen of Nebraska also bear in mind that two more railroads will traverse the country as far as the 100th meridan; one from Kansas, which will tap our Territory early next spring, and the other from Plattsmouth. 
