

Harding Approves Plan to Celebrate National Navy Day

President Says Highest Efficiency Necessary Under Program of Reducing Armaments.

Washington, Oct. 25.—President Harding's approval of the celebration by the nation of Navy day on Friday, is formally expressed in a letter from the president to Secretary Denby today at the Navy department. It was written in answer to Mr. Denby's report that plans for the celebration over the country had met with "very cordial response." The president's letter follows:

"My Dear Secretary Denby: Thank you for your note which brings assurance of the notable success which seems certain to attend the celebration of Navy day, on Friday, October 27, in commemoration of past and present services of the navy. From our earliest national beginnings the navy has always been, and deserved to be, an object of special pride to the American people. Its record is, indeed, one to inspire such sentiments, and I am very sure that such a commemoration as is planned, will be a timely reminder.

"It is well for us to have in mind that under a program of lessening navy armaments there is a greater reason for maintaining the highest efficiency, fitness and morale in this branch of national defensive service. I know how earnestly the navy personnel is devoted to this ideal and want you to be assured of my hearty concurrence.

Commenting on the Navy day celebration, Secretary Hughes declared it would be upon a basis of relative naval strength that "we would enter in future conferences to make agreements for limitation, and it would be folly to undermine our position."

"The celebration of the Navy day," the secretary of state said, "has my hearty approval. This government has taken the lead in securing the reduction of naval armament, but the navy that we retain under the agreement should be maintained with efficient personnel and pride in the service. It is essential that we should maintain the relative naval strength of the United States. This in my judgment, is the way to peace and security. It will be upon that basis that we would enter in future conferences or make agreements for limitation, and it would be folly to undermine our position."

Court Refuses Stay in Ship Liquor Fight

Washington, Oct. 25.—Despite the acquiescence of counsel for the federal government in the petition, Supreme Court Justice Brandeis refused to grant foreign shipping lines a stay against the enforcement of Federal Judge Hand's decision at New York Tuesday, which applies American prohibition regulations against their transportation of intoxicating liquors in American waters.

Simultaneously with the refusal of the supreme court justices to give relief to the complaining ship companies, however, it was announced at the Treasury department for the present, at least, foreign ships would still be permitted as a matter of policy to enter American waters with liquor on board under seal.

War Cabinet Is Described in Detail in Lane Letters

Intimate Picture of Woodrow Wilson Is Made Public by Widow of Former Secretary of Interior, Who Publishes His Letters Telling Inside Story of Conduct of Affairs During World War.

Boston, Oct. 25.—(By A. P.)—A series of history-making letters, describing in detail the American war cabinet and giving an intimate picture of Woodrow Wilson, as he appeared while presiding over the secret meetings of his official family, was made public yesterday.

The letters, written by the late Franklin K. Lane, secretary of the interior in the cabinet of President Wilson from 1913 to 1920, have been collected and edited by his widow, Anne Wintermute Lane.

The correspondence reveals, among other things, how the president frequently lost patience with the treacherous problems confronting him and how, at other times, discouragement crowded him to such a degree that he was prompted to turn bitterly upon his advisers, when they failed to agree with him.

Describes War Feelings. The letters give a description of Mr. Wilson's attitude on preparedness before America entered the war, tells how he regarded the proposal to arm merchant ships, describes his opposition to anything approaching the "code duello" spirit at a time when the United States was neutral, and then, when great questions were pressing for decision, tells how he encouraged his cabinet to talk of realities while he went along on his own counsel to solve the huge problems facing his administration.

"The president said he didn't wish to see either side win—for both had been equally indifferent to the rights of neutrals," Mr. Lane wrote to his brother February 17, 1917, commenting on a particularly animated cabinet discussion. Writing again to his brother, February 16, 1917, Mr. Lane said:
