It only remains for the republicans of Pawnee county to endorse Judge Tucker. His name will go on the ballot as the republican candidate for float senator and his election is assured. He is the man for the place and the place is waiting for the man.

By the manly stand he took in the senatorial contest, J. R. Cain, jr., has made a host of friends. What the party needs is more of this kind of men; men who are unselfish and who can make a self-sacrifice for the good of the party. The reward that is due such a man will not be long withheld.

The last issue of the Journal gave to the republican party the following belated "fatherly" advice: "It is the duty of every party man to go to a caucus. OUR TICKET.

Now that the county convention is over the republicans have just reason to rejoice in the results that it brought about. Its enthusiasm, its unity of purpose and its harmony are indeed gratifying. But there is another source of gratification, and that is the excellence of the ticket selected. No matter how united a party may be, or how enthusiastic and harmonious, if it nominates weak or incompetent men, it has at the outset materially lessened its chances for success.
