Council Meets.

City Council met in regular session Monday evening March 6th. Mayor Holt presided and all members were present. The minutes of meeting held Feb. 6th were read by Clerk Brown and approved.

Claims were allowed to the amount of \$1201.02. A committee representing The Farmers Mutual Telephone Co., appeared before the council and Messrs Weaver and Morehead of the Falls City Telephone Co. After consideration of the matter the admittance of Farmers Mutual was deferred until the next council meeting. Contract for a new well at the water works was given to J. F. Richarts, work to commence at once.

Ed Burris was sworn in as councilman from second ward to fill the vacancy caused by the resignation of Frank Clegg.

Council then adjourned to meet on April 3rd.

At a special meeting held Tuesday evening of the council and the committee of citizens appointed at a previous mass meeting, the water supply was debated. A few hours were spent in discussing a probable location for such a supply, some arguing to locate within the city limits and others to have it outside. It was finally agreed to make three tests the first one near Abbotts lakes on land belonging to Wm. Maddox, the second on the Wm. Holt land and the third to be somewhere on the Nemaha bottom between the place of George Hinton and George Dorrington. The work was to be commenced immediately so a final decision could be arrived at in about thirty days time. Mr. Kurston, who installed our city plant about seventeen years ago will be in Falls City in a few days and will be able to give a few pointers. Several plans were discussed but no other business was transacted.
