**"Official" All-Western Later**

The "official" All-Western team is yet to come. It is selected by E. C. Patterson and will appear shortly in Collier's Weekly. Next to Patterson's selection, Eckersall's is generally recognized as official. On the Tribune critic's eleven, Chamberlain is the only Nebraskan awarded a position on the first team, while Rutherford and Abbott are placed on the second eleven.
