Alpha Chi Omega, Student Council, and Gamma Delta Chi, and Marjorie Williams, an associate editor of the Cornhusker and member of Kappa Kappa Gamma, are also vying for the position.

The fraternities will be required to battle over Ivy Day orator and senior and junior presidencies since no barb candidates are listed in the filings. The blue shirts have placed Russell Mattson on their slate for Ivy Day speaker. He is president of Phi Delta Phi, president of the senior law class, Kosmet Klub master of ceremonies, and member of Delta Upsilon.

Christian L. Larsen has been advanced by the yellow jackets to oppose Mattson for the Ivy Day portfolio. Larsen is a member of assistant in the debating team, is an assistant in the department of political science, and is affiliated with Alpha Theta Chi.

John Brown and Adolph Simic are out after the senior presidency. The former is a yellow jacket, a senior football manager, lieutenant colonel in the military department, a member of Scabbard and Blade, Pershing Rifles, and Sigma Chi. Simic, the blue shirt man, is connected with varsity athletics—wrestling and football—and is a member of the N club and Alpha Gamma Rho.

Only two juniors have signified their intentions of being class president. Robert Kelly of the blue shirts is a member of the student council, a managing editor of The Daily Nebraskan, and is affiliated with Pi Kappa Alpha. As their choice, the yellow jackets have Roger Robinson, a Phi Kappa Psi, a member of Kosmet Klub, sponsor of the interfraternity sing, and one of the singers in the University quartet.

The only independent candidate on the entire slate is Adelaide Burr, a Gamma Phi Beta, and A. W. S. board and Intramural board member. She is striving to be sophomore class president. Miss Burr's opponents—three in number—are members of the campus factions.

William Comstock, yellow jacket is a Phi Delta Theta, Corn Cob and is assisting in the Cornhusker office and Kosmet Klub work. Lloyd Jefferies, blue shirt, Corn Cob and Alpha Sigma Phi, is another candidate for sophomore president, as is Evelyn Lee, the barbs' choice. The latter is secretary-treasurer of Vesper choir.

All factions are likewise represented in the run for first year president. Glendon Brooks, a Lambda Chi Alpha, is the blue shirt's yearling while Duane Lyon, who is out for freshman basketball, is the barbs' choice. Arthur Pinkerton is being backed by the yellow jackets. He is a Sigma Alpha Epsilon.
