"Don't ask me why," Victor said. "I've because people thought we were phoneys. There was so much Beatle junk being sold those days — the drugstores were full of it."

The second thing that happened to Victor and Einhorn was that they received a letter from a New York attorney named Walter Hofer. Hofer's letter said:

"Gentlemen: Please be advised that this office represents the interests of Paul McCartney, George Harrison, Ringo Starr, John Lennon individually and collectively known as the Beatles.

"It has come to our clients' attention that you are advertising and offering for sale certain linens allegedly used by the Beatles; and in connection therewith using the name of our clients. We are advised that you have not received authority or permission from the Beatles in connection with same.

"Your activities in this connection are causing great damage to our clients, and unless you immediately cease and desist this improper and unauthorized activity, we shall have no alternative but to proceed in accordance with our clients' instructions."

So on the one hand Victor and Einhorn had 164,000 pieces of Beatle bedsheets that no one believed were real, and no one wanted to buy; and on the other hand they had the Beatles' attorney threatening to sue them.

"I think we sold between 700 and 800 of the pieces of sheets," Victor said. "We lost money. We didn't even get back what we paid for the sheets."

And now 20 years have passed. Vic-National news outlets picked up the tor dropped by the other day. He gave me tour pieces of Beatle bedsheets.



your need for salvation. Man thinks he has the answers, or feels there is an alternative, but God says there is only one way to heaven and that is through the death of his son. Julie Dennis




