The leading cereals, corn, wheat, oats, rye and barley, cannot be excelled by any of the older States. Wheat, red, white and winter, will equal that of the far famed "Red River" country, both in quality and yield per acre.

The display of corn was very fine, ears large, round and well filled. The following weights are appended: Corn, white and yellow, weight per ear,1 lbs.; squash 67 lbs.; beat, 14 lbs.; onion, 14 lbs.

The live stock display was creditable to the farmers in this section; among the swine were Poland Chinas and Chester Whites. Durhams took the lead in cattle. Norman and Hambletonians were

conspicuous among horses. A large part of these products were grown on ground that five years ago was unbroken prairie. The display will give an impetus to this section of our State and a guaranty of its agricultural capability, and also demonstrates the fact that the 100th P.
