WORK OF TRAIN ROBBERS.

While the Conductor Slumbered the Passengers' Clothes Were Stolen. SALT LAKE, U. T., Sept. 15 .- [Special Telegram to THE BEE. - From Van Cullen Jones, a representative of the New York World, who arrived here today from San Francisco, the first information was obtained of the robbery of the passengers on the Pullman sleeping cars San Juan and Uintah, some time last Sunday night. The robbery is supposed to have occurred between Sacramento and Winnemucca, Nev. Everything indicated that the robbers had intended to hold up the passengers in true western style, but when the train stopped at one of the lonely watering places they entered the cars and found conductor and porters asleep, making such a procedure unneces-sary. They did not take the trouble to go through the pockets of the occupants of the cars but took their ciothing and everything along.

To show the facetiousness of the footpads

several of the passengers found that their revolvers had been taken from their revolvers and been taken from their clothing and had been laid beside their pillows. At the request of the Pullman company no publicity was given to the affair, the company giving a quasi promise that restitution would be made. Applications have been made to the Pullman's western representatives but they have given no satisfaction or promise that the company will reimburse the passengers for the neglect of duty of its employes. The aggregate loss in the two coaches was over \$4,000.

> Scenes of Disturbances Outside of the Theater, But a Riot Was Not Precipitated-Extraordinary Precautions Taken.

Panis, Sept. 16.-The performance of 'Louengran' commenced at 8 o'clock this evening. The precincts of the opera house were crowded, but up to that time only a slight attempt had been made to create disorder. The police had strict orders to take energetic action if necessary. The "claque" seats were occupied by detectives, and all approaches to the corridors were occupied by police and an inspector stood by each checktaker to scrutinize incomers. Mounted republican guards kept the streets clear. The house was crowded, there being no

special difficulty in oftaining admission. The

overture was listened to in profound silence, the audience breaking into rapturous applause at the conclusion. The opera was admirably mounted and finely rendered. Van Dyck and other artists were recalled several times and applauded to the echo. There was a noisy demonstration outside the opera house during the performance. By 9 o'clock the scene outside the opera house was of the liveliest description. The payement was almost impassable and there was a sprinkling of anarchists and other rough characters in the crowd that thronged it. A band of students sang the "Marseilles." The crowd responded with cries of "Vive la France!" "Abas Wagner!" Portions of the mob continually made rushes against the police cordon, and the police, whenever these incursions became formidable, assumed the offensive and charged the mob, which would everal times and applauded to the echo. deaths reported in the city of Aleppo from and villages where the postilence is raging effensive and charged the mob, which would take to flight in hot haste. Then the singing and shouting would soon be renewed, but rushes and charges repeated. In several in-stances respectable onlookers were roughly nandled and arrested on the slightest provo-cation and then cuffed if they ventured to make the mildest protest. MEXICO'S PROSPERITY.

President Diaz Opens Congress and Reviews the Republic's Progress. CITY OF MEXICO, Sept. 16 .- President Diaz pened congress last night. In his speech he Foster issued a circular this afternoon giving

said: "Our foreign relations are excellent. I have named a commissioner to the monetary convention at Washington. Also a commissioner to arrange a treaty of reciprocity with the United States. The convention with Guatemala in arranging the frontier limits has been extended two years. The mixed claims commission of Guatemala and Mexico expired without finishing its work. Mexico is trying to obtain an extension of the time of the commission.

"Treaties of peace, friendship, commerce and navigation have been signed with Santo Domingo and Italy. The Mexican govern-ment refused coal to the Chilian vessel Esmeralda, but afterward consented to sup ply a small quantity which was absolutely necessary for the sailing of the ship. The Chilian junta asks for recognition, but we have demanded time for investigation, as we wish to be neutral. Diplomatic relations have been commenced with Japan, the Argentine Republic and Russia. Mexico sent a commissioner to the geographical congress recently held in Switzerland. A new ministry, that of communications and public works, has been established. A new sanitary code has been promulgated. The penal code has been reformed. The school system has been improved. Mining is progressing. Public land is being rapidly taken up. Agriculture is flourishing. Mexico has accepted the invitation of the United States to attend the Chicago exposition, and I expect that congress will grant the amount of money necessary, that we may make a show-

ing worthy of the place we occupy among civilized nations.

"Our postal relations with foreign countries are good. In the interior we are extending postal facilities and routes. The postal receipts last year amounted to \$1,007,-Seven new steamship lines have con tracted to carry the mails without a subsidy. The government telegraph lines are being extended the same as railroads. Monterey & Gulf railroad is finished to Tampico. The Intersecanic is finished to Vera Cruz. The Tehuantepec railroad con-tractors have been ordered by the govern-ment to finish the work. All the lines are promising and there are now 10,105 knome tres in operation. New highways are being The works at the ports of Vera Cruz and Tampico are progressing. The Tehuan-tepec route will soon be open from the Pacific to the Atiantic. The works for drainage of the valley are progressing. Our light houses are being improved. New customs tariffs have been published with a liberal reform to in-

rease commerce. "I am sure that our receipts will more than cover the expenditures and that, as bereto-fore, money will be placed in Europe to pay interest in advance. Banks are operating regularly and increasing their business daily and no fears of a crisis are entertained, because I shall take care that their circulation remains within the specified limits. Our credits abroad hold a distinguished place, subject to slight natural fluctuations. Indian troubles in Sonora have ended, army is being mobilized scientifically."

In conclusion the president said: "You see the country progressing and developing its natural elements without the precipitaon of convulsions of any kind and consecutive without the risk of crises or panies and we show the world a country satisfie with its institutions, dedicated to the peace ful development of its natural resource tending to the consolidation of her credit by business reserve and respect for obligations.'

Bartender Fred Smith Cut Down by an Unknown Man. Fred Smith a bartender at James Carr's saloon, 915 Jackson street, was stabbed and probably mortally wounded in the rear of

the place about 10:40 o'clock last night. According to reports the story is about as follows: Smith left the bar about 9 o'clock to go up town to supper. When he returned he went into the rooms of Jennie Lester in the rear of 909 Jackson street.

ground, as his enemy ran out of the yard and down the alley. Regaining consciousness in a moment or two, the injured man staggered through the rear door of the saloon and into bar room. As he sank to the floor he cried; "Send for a doctor." Barkeeper J. B. Brendel rushed to the

failen mun's assistance, and seeing his condition immediately sent for a physician. The police were notified and Smith was taken to the home of his father, 512 South Ninth

It is supposed that an ex-back driver

named J. C. Pauley did the entting. Pauley has been paying considerable attenion to Jennie Lester, and he was seen about the place a few minutes before Smith was stabbed. The assault and escape was made so quickly that it was impossible to say positively who the guilty man is. But everything points to Pauley, who has a bad reputation.

Jennie Lester was taken to the police headquarters and closely questioned. As she did not see the affair she could tell but little. However, she was locked up and held as a witness.

Three doctors were called and worked over smith for some time. They found that the knife blade had penetrated the right lung and that the patient was losing a great deal of blood, both externally and internally. The physicians gave it out that the man was in a very dangerous condition and was liable to die before morning.

the case and started on the trail of the young man where he camped for a good many days. The much wanted thief traveled generally in tramp style, using box cars when possi-ble, but two or three times changing his Clothing and riding in a passenger couch. Keenan traced and followed his man through California to San Francisco, then to Virginia-City and Ogden. From there Cusick went to Green River, Rawlins, Cheyenne, Donver and finally to Omaha. When he reached this city the sheriff was close behind bim and had the pleasure of placing the bracelets on him before he read his old home at Fort Omaha.

Cusick has been in lots of trouble. He is reported to have shot two soldiers and his own father at Fort Omaha before he was 15 years old, when the Ninth infantry was stationed here. His mother has spent \$8,000 or \$10,000 in getting him out of trouble, but this time it will be no use. LIBERTY NEAR.

Bidwell, the Bank of England Forger. Will Be Released Next February. Chicago, Ill., Sept. 16. -A cablegram from London this morning announces that the sentence of the notorious American forger, Austin Bidwell, has been cut down and that he will be released February next. William Pinkerton, who effected Bidweil's capture, when shown the cablegram today, expressed his entire satisfaction at the remitting of the sentence.

"The poor fellow has been in prison al most twenty years." said Mr. Pinkerton, "and he is, I think, sufficiently punished for his crime. That forgery is one of the great-est on record. Bidwell and his brother for-merly ran a candy store on Madison street. in this city. They went away and finally conceived the plan of looting the Bank of England. A number of bills of exchange were counterfelted and \$1,000,000 were secured on them. The forgery was discovered that night and the police went to work. Previously I had furnished the London police with photographs of the gang and by these they were enabled to fix the crime where it belonged." Austin Bidwell made his escape to Cuba,

where Pinkerton caught him in company with his bride. Bidwell escaped but was re captured and taken to England where he was rief and sentenced in 1874. A cipher letter to Bidwell gave a clue which led to the re covery of \$250,000 of the money which had been converted into United States bonds. In the meantime the older Bidweil brother had een captured in Scotland and was sentenced or life. Becoming paralized while in prison his pardon was procured. Since that time he and other members of the family have been tireless in their efforts to secure the relesse of Austin, who was but 25 years of age when he was sentenced.
