MAIL ROBBERS IN LIMBO.

During Thieves Under Arrest After Successful Tour of the Country, THEY OPERATED ON LETTER BOXES.

Big Hauls Made in Cash and Checks—Bank Officials Easily Guiled—How They Were Finally Captured.

New York, Nov. 10.—For skill, audacity and success on a large scale, the letter-box robbers have just been arrested by post-office inspectors.

They worked systematically in August, 1900, and since that time they have robbed the mails in Washington, St. Louis, Chicago, St. Paul, Cleveland, Cincinnati, Pittsburg, Louisville, Nashville, Denver, New Orleans and other places.

The authorities have stolen checks for \$25,000 which the thieves had cashed, and the proceeds of all their robberies for the last five months must have amounted to twice that sum.

The leader of this gang is Charles Hubbard, alias Charles Diamond, and his associates are J. K. Stratton, T. C. Hoan and J. C. Clary.
