Adjusting Indian Land Sales.

Senator Paddock today introduced a substitute for his bill of December 14 last, providing for the adjustment of certain sales of land in the late reservation of the confeder-ated Otoe and Missouri tribes of Indians in Nebraska and Kansas. The first section of the substitute of today authorizes the secretary of the interior to revise and adjust on principles of equity the sales of lands in the reservation of the confederated Otos and Missouri tribes of Indians in Nebraska and Kansus provided by the act of congresproved March 3, 1881, to be appraised and sold in the manner specified in the act, and which were sold at public sales at the land office at Beatrice in May and December, 1883, and in his discretion with the approval of the president o the United States, the consent of the Indians having first been obtained, to allow to the purchasers of the land at the sales referred to, their heirs and legal representatives, rebates of the amounts respectively paid or agreed to be paid by said purchasers, provided that such rebates shall in no case exceed the price for which said tracts of land were severally sold in excess of the appraised value thereof as shown by the appraisement made by the commissioners appointed and

designated under the act. Section two provides that as soon as practicable after such adjustment and rebates, if any, shall be allowed, shall be severally endorsed in the certificates and receipts of pur-chase and on the records of the general land office, and the secretary of the interior shall cause notice to be given to the purchasers severally of the mounts of the deferred payments found to be due and unpaid on their respective purchases under such adjustment and in default, the payment in cash of the amounts thus found to be severally due within one year from the date from the issuance of such interest, and with interest thereon from date of such adjustments. The entries of any of the purchasers so in de fault shall be cancelled, and the land shall be resold at not less than the appraised price and in no case less than \$2.50 per acre, as pro vided in the act of March, 3, 1881. PARTY LINES WILL NOT BE DRAWN.

Democrats Will Support the Administration in the Chilian Troubles. Washington, D. C., Jan. 24.-There were no new developments today regarding the Chilian situation. It was reported tonight that Secretary Blaine had received a messsage from Mr. Egan, but the secretary said this evening that there was no news for the press. Secretary Tracy and Minister Montt also appounced that they had no news tonight.

Although the fact that the ultimatum which has been sent to the Chilian government does not necessarily imply that war will follow, yet the fact that affairs had reached such a serious stage was the subject of talk everywhere in Washington today. On the streets, in the clubs, hotel lobbies and al praces where men congregate, the Chilian matter was the chief topic of conversation. The ability of this government to wage a successful war with Chili was freely discussed and the opinion was unqualifiedly ex-pressed that there would be no trouble on

The Post tomorrow will publish interviews with several prominent persons on the subject of the Chilian troubles. The most interesting is the one with Representative Holman of Indiana, who spoke substantially as follows

Talk with Mr. Holman.

"Of course we must consider the results of any action that we may take against Chili. Suppose we should go into a war, what would be our relations toward Peru and Bolivia after the trouble was over Of course these two nations would be involved with us. Must we protect them from the resentment incurred by the contest? If so, how long will the obligation rest, upon us? There is no doubt about our ability to conquer Chili. to practically annihilate her if we needed to go so far. Chili could be conquered with our present army and navy in four months, I think, and if this force would not suffice, look at the resources back of them. But the war itself is a small part of all that must be taken into consideration. The loss of life would be almost nothing, but what are the consequences! Not only the question of a virtual protectorate over Peru and Chili, but the effect of the war upon other South American nations must be considered. How will our relations the other governments continent be affected if nat continent be affected it United States makes war upon What would be its influence upon the senti ient those nations toward us! In the course of time you would see a great syndicate of all the governments upon these two continents. Not a union, of course, like our states, but a close alliance. We must think of the effect upon this movement of any action toward Chili. I shall not care to any opinion as to what should be done until I get all the facts from the president. the face of the world. It Was an Eloquent Vindication. It was a brave and elequent vindication of the able and fearless Egan, who has so well and favorably served his adopted country, thereby conspicuously honoring his own nationality.

Some say we ought not to notice their cruel assaults upon our seamen, their indig nities to our government and our flag, be-cause Chili is small and weak. She was strong and cruel enough without provostrong and cruel enough without provo-cation to crush and rob her smaller and weaker sister republic, Peru. She is strong enough now in her own vanity to believe herseif entitled to the place of primacy among the republics of the western hemis-phere. It would be useful to her, it might save her from worse trouples hereafter deed it might save her from herself and self-destruction, if the United States could pick the little swell-head up by the slack of her nether garment and soundly cuff her ears.

Should Make Her Come to Time. Unless she makes the fullest and most ample apology we ought to send down our big ships of war and supplement their movements by a land force of a hungred thousand or more made up of equal numbers of the brave men or the sens of the brave men who wore the bive and the gray in our unfortunate civil conflict a quarter of a century ago. I might happen us to forget the estrangement of the past: it might help to more thoroughly sections which strove for mastery in that memorable struggle. So far as I am concerned I am ready now to vote for a declaration of war."

WAKED THEM UP.

Blaine's Message to Minister Egan a Sur-

prise to Chilians. [Copyrighted 1892 by James Gordon Bennett.] VALPARAISO, Chili (via Galveston, Tex.) Jan. 24.- By Mexican Cable to the New York Herald-Special to THE BEE, |-The uitimatum of the government of the United States that Chili must immediately, and without reservation, withdraw the offensive note of Senor Matta, ex-minister of foreign affairs, apologize for the assault upon the sailors of the cruiser Baltimore and pay in demnity for injuries inflicted upon American citizens, has been handed the Chillan govern ment by Minister Egan.

This is the reply sent by the United States to the demand of the Chilian government for the recall of Mr. Egau.

The prompt sending of this ultimatum in stead of an order to Mr. Egan that he return home has surprised the Chilian government, and it is rumored that President Jorge Montt, who is resting at a bathing resort, has been asked to return at once to Santiago and consult with his cabinet and council of state in regard to the matter.

In a Mighty Ticklish Place. I had interviews tonight with Edward Motte and Judge Alfonso, both of whom are members of the council of state. When

informed them of the nature of the ultimatum sent by Secreeary Blaine they expressed considerable surprise at its terms, and, without formally committing them selves, both agreed that it would be a supine act to now withdraw Matta's letter. They expressed the hope that at the meeting o the council of state in conjunction with the cabinet to-morrow, peaceful solution of the difficulty might be arranged. Judge Alfonso, who is well known to Secretary Blaine, said that

any war between the two countries would be exceedingly foolish, and he was fully convinced that the United States did not desire to humiliate Chili. When I saw Don Carlos Walker Martinez tonight, he expressed deep regret that the Chilian cabinet had brought the matter to such a crisis, and evinced strong hope for a

peaceful settlement of the difficulty. He has doubt that the sentiment of the Chilian congress will uphold these views.

Minister Egan's Backbone. During the past week, in spite of the show of friendship towards Minister Egan by Senor Periera, minister of foreign affairs, and other members of the Chilian cabinet, events have come to light exhibit ing surprising duplicity. Minister Egan was asked last week by the Chilian foreign office to "recognize" the fact that Secretary Blaine had accepted the renunciation of Matta's circular letter by the Chilian government, the so-called renunciation being forwarded upon the explanation that President Harrison's message was a domestic document and it was therefore improper for a foreign government to officially comment upon it. Mr. Egan declined to entertain the proposition until after he had communicated with the Washington government and obtained instructions

from his own superiors. He declined to acknowledge the "regunciation" upon the ground stated by the Chilian authorities without official information from Washington. When the request in regard to the Matta note was made Minister Egan he was told that a letter in regard to the subject would be sent to the American legation. The promised letter was not sent. On the contrary, the Chilian government cabled Senor Pedro Montt, its minister at Washington, to demand the recall of Mr. Egan because he was persona non grata.

Instructed to Sever Diplomatic Relation Secretary Blaine's reply to the demand for Minister Egan's recall was delivered yesterday. Instead of being an instruction to Mc Egan to return home, it instructed the American minister to deliver the ultimatum of the United States government to the Chilian authorities.

This ultimatum demands the immediate and unqualified withdrawal of the Matta letter without reservation, an apology for the assault upon the sailors of the Baltimore and the payment of an idemnity. It is couched in an extremely firm and decided tone. Min ister Egan is instructed if the demand is not complied with at once to sever diplomati relations with the Chilian government.

Chilian Public in Ignorance. The Chilian public is not aware of the gravity of the situation, nor does it know that the American ultimatum has been re ceived. The cabinet has been acting secretly and is accused in some quarters, not only of giving out false news to the public, but also of keeping the real facts from the counsellors of state. Vague and uncertain rumors have gained circulation in Santiago and Valparaiso, but

the real danger is not generally known. Mr. Kennedy, the British minister, acting under instructions, from the government, went to Santiago this morning to offer his

friendly offices as a spediator. I am confident that the United States gov ernment will receive all it demands, and fully believe that the action of the cabinet in allowing the present complications to arise will be censured comorrow at the meeting of the Chambers. There is a marked sentiment, however, in army and navy circles against saluting the American flag, should that be demanded. I am privately informed that British Admiral Holtam, is very much opposed to the foorish policy of the Chilian government.

Fiendish Murder of a Young Woman by a Memphis Girl.

CUT HER THROAT ON A CROWDED STREET

No Cause Given for the Awful Crime-A Sensational Tragedy-Assault on the Murdered Girl's Sister-Arrest of the Murderess - Details of the Affair,

MEMPHIS, Tenn., Jan. 25,-The most sensa-

tional tragedy which has occurred in Memphis for years was committed about 4 o'clock this afternoon. The victim was a young lady, and her slayer was of the same sex Both were familiar figures in society, and the awful affair is tonight the talk of the town, A few minutes before 4 o'clock a buggy containing Alice Mitchell and Lizzie Johnston drove up to the broad sidewalk around custom house block leading to the levee. The lines were in the hands of Miss Johnston, and beside her, calm and selfpossessed, sat Miss Mitchell, Coming slowly up the steep incline from the river were Miss Freda Ward of Golddust, Ark. and her sister Jo, who had just put another sister, Mrs. Cummings, aboard the steamer Rosa Lee, for Golddust, Ark. The young ladies were soon opposite the carriage, chat-ting pleasantly and paying no attention to the surroundings.

Cut Her Throat.

Suddenly from out the carriage, at a bound came Miss Mitchell. Grasping Miss Freda Ward by the neck, she drew a bright razor from out the folds of her dress and without a word drew it across the throat of her vic-Miss Ward sank to the pavement in an instant, the blood pouring in torrents from the severed jugiar vein. The murdered girl's sister, who had by this time recovered from her astonishment, grappled with the woman and tried to hold her, but in a twinkling she, too, received a cut, but tuckily only a trifling one near the ear. Mis-Mitchell being freed from Miss Ward, jumped in the buggy and with the exclamation, "drive quick; I've done it," seized the whip and with Miss Johnston still holding the lines the pair were soon around the corner and away from the scene of the

ragedy.
Miss Ward was tenderly picked up by the crowd and a passing carriage, which was pressed into service, conveyed her to Rogers nfirmary. She was, however, beyond human aid, and expired just as the infirmary was reached. The body was then taken to an undertaking establishment.

Arrest of the Murderess

At 6 o'clock this evening Chief of Police Davis had arrested Miss Mitchell, who was found at her home on Union street, and con reyed to the jail.
The cause of the killing is tonight not

positively apparent as Miss Mitchell refuses to say a word to anybody on the subject. It is said, however, that Miss Ward, who i visiting in this city, had on former trips to Memphis been the guest of Miss Mitchell Lately, however, she has refused to partake of the hospitality of the Mitchell household and refused also to recognize Miss Mitchell on the street. It is alleged further by several persons that Miss Ward has made remarks of a decidedly uncomplimentary nature regarding Miss Mitchell, and this latter allegation is supposed to have been the cause of the tragedy.

Miss Mitchell is the 19-year-old daughter
of George Mitchell, a retired furniture

Miss Ward is the daughter of John Ward a planter and wealthy merchant of Golddust

Realizes the Prat's Danger. Advices from Captain Evans and from special agents abroad who are sceping the de-partment advised as to the progress of the Captain Prat have caused the conviction that a movement is speedily to be made to get the Prat away from France and into Chilian waters. The dispatching of the Ex-merald and her consorts southward, it is now thought, is a part of the plan. They are believed to be getting into a position to come quickly into the Atlantic to join the Prat the moment that hostilities occur. As pointed out in these dispatches, the Prat in her present unfinished condition, with a green crew, would fall an easy victim to the Philadelphia or any medera cruiser of her type. The Chillans doubtless realize this as

well as Americans do. It is therefore proba-

bie that they will send available vessels around to meet and protest her from attack while enroute to their own waters. The possession of the Prat means a great leal to Chili, and nothing will be left undens by that government to get her out of neutral ports at the earliest moment. Secretary Tracy understands that her presence in Chili will greatly augment the task before the United States. It is important that this government should exert every effort to prevent her being turned over to Chill or cap-ture her before she get: into the Pacific. Rear Admiral Walker has, it is understood, been advised of the suspicions of the Navy lepartment concerning the movement of the Chilian vessels, and it is believed that white Admiral Gherardi is watching the Prat in the northern Atlantic, Admiral Walker will keep track of the movements of the Chilian

Have Another Cruiser Ready.

A startling piece of information is said to have reached the Navy department which adds to the seriousness of the situation. The agents of the department in Paris report that the Captain Prat is not the only Chinan ves-sel preparing for sea at the French ship-yards, but that the cruiser Presidente Pinto is fitting out for service at a French Atlantic port, and that she is netually ready to sail. She corresponds to the Montgomery of our navy, or cruiser No. 11, built at the Harrison-Loring works in South Boston, only that she is more formidable. She has an arma-ment composed of Canet rapid-firing guns, and if she succeeds in getting away she will make things lively in the Atlantic. She has a good speed, and is altogether a machine of war to be feared. Her guns have not been mounted yet, but they are on the wharf and

everything is in order for hasty sailing.

If Chili succeeds in her evident plan of de-laying action in this country for three or four weeks longer, the United States will find it a difficult matter to secure from that nation any terms, and a naval expert is authority for the statement that the United States will find it impossible to defeat the Ihilian forces. - They already have a warlike fleet that has been drilled and otherwise put into condition for actual service. They have increased their stock of torpedoes and have supplied all their ships with smokeless powder. The Pinto has taken on a supply of this modern ammunition. They are at work on their coast defenses, and have so far procressed with their projects that a few more weeks will see them on a very formidable war footing, and one that will make the planned invasion of Chili by the United States forces extremely difficult.

Sending Out False News. The Navy department is laboring under he disadvantage just now of having no source of information from Valparaise but the latest advices from that port are any-thing but reassuring. The department has learned to distrust their dispatches which have come from Chili, as they are so ob-viously in favor of the Chilian side of the case as to lead to the assumption that the inormation is purposely against this country.
