POLICY OF THE ADMINISTRATION. All Financial Legislation Will Have

Walt on the Repeal Bill. Washington, Sept. 5 .- The financial policy of the administration was clearly defined today. It is that all secondary financial leg-Islation be postponed till the senate acts on the repeal bill. The house committee on banking and currency, to which falls the duty of originating legislation to follow re peal, met this morning, but at once adjourned for a week. It is learned that the president and Secretary Carlisle expressed a wish that all remedial legislation be postponed till the repeal bill had actually passed the senate. There is no doubt the committee intends to follow this suggestion. The object is to put spurs on the senate by concentrating public attention on it. The house will keep the road clear for the immediate consideration of repeal as soon as it comes from the senate.

Voorhees' Announcement. During the meeting of the senate committee on finance this morning there was an informal discussion of the policy to be pur-sued with reference to measures now before the senate which have been reported by this committee. Senator Voorhees announced in unmistakable language his determination to push the repeal bill as rapidly as possible and indicated that this would be done it least for the present without reference to other bills which the committee has had under consideration. This is taken to mean that, whatever truth there may be in the rumor that the administration has old finan-cial plans browing or that Mr. Voornees is himself anxious to secure other legislation, all these schemes will be at least temporarily held aloof and the repeal bill given undivided attention. It is, inded, asserted that the more the announced purpose of the administration to press bills for the removal of the tax on state banks and for the coin age of silver seignorage is exploited, the less favor it finds with the advocates of repeal, and there are those who assert that the position which the New York bankers have assumed against this policy is having its influence in sidetracking the state bank tax and seignorage coinage propositions. This charge is made by the opponents of repeal, and its truth is not admitted by the advocates of that measure. Whatever may be the influences at work, there is no doubt after Senator Voorhees' declaration in committee that the repeal measure is for the present to receive the undivided attention of the senate, if Mr. Voorhees can control and that it is not to be in any

Will Demand a Quorum. Senator Harris also made an important announcement in the meeting on behalf, it is supposed, of the opponents of the repeal bill. This was to the effect that hereafter it was his purpose to demand that at all times there shall be a quorum in the senate. This announcement is supposed to have originated in the state of affairs discovered in the senate yesterday. After that body had refused to adjourn, to permit Senator Peffer to postpone his speech until this morn ing, it became apparent that a large major-ity of the senators had taken their departure for their homes, leaving the senate chamber comparatively vacant, and that some at least of the absentees were there who had announced by their votes their desire to have the business of the senate continue. VETERANS IN CHARGE.

Indianapolis Given Over to the G. A. R .-Yesterday's Great Parade. Indianarous, Sept. 5 .- This is the great day in the Grand Army encampment. The veterans are all here and have possession of the city. All the hotels, all private residences, all school houses and other public buildings are full, and all the squares and vacant places are dotted with white tents. Great barracks, capable of accommodating nearly 50,000, are entirely taken up with visitors. The arrangements are so complete, however, that all are cared for without confusion. There are bureaus of information at all prominent places to direct inquirers in the right road. Surgeons and ambulances

People began to gather along the route of the parade with the rising of the sun. Everywhere stands were placed to furnish points of view. Orderlies dashed here and there getting posts, battalions and divisions in order, the bands played and the multitude cheered. The spectacle was never before equaled in this city. The weather was perfect, a cool, light breeze with thin clouds tempering the

The column began forming at the corner of Meridian and Seventh streets, with the various detachments extending many blocks on all the adjoining streets. The line of march was down Meridian street to New York, west to Pennsylvania, south to Market, east to New Jersey, south to Wash ington, west past the reviewing stand to Tennessee.

The procession moved down the flag-covered streets preceded by a platoon of nounted police, followed by General J. R. Carnahan, grand marshal, and staff, 200 mounted men in full uniform. Next came the naval veterans, followed by a great float representing the Monitor, with the words of Farragut: "Damn Torpedoes; Go Ahcad." The second detachment of the parade was led by Captain Jack Crawford in a scout's dress. Illinois had the place of honor in the lead of the procession proper and headed by Department Commander Biodgett, turaed out 2,000 men. In the middle of the line a company marched singing "We'll Hang Hoke Smith on a Sour Apple Tree." The sentiment was both hissed and cheered. Next came the Department of Wistonsin tive posts 300 men, with ment of Wisconsin, five posts, 300 men, with Old Abe, the bald eagle, at the head. Then followed other states in order, making a grand, inspiring turnout.

The Indianapolis citizens' executive

board gave a reception to the Grand Army of the Republic and invited guests at Tomlinson's hall last night, about 8,000 people being present. The prominent speakers were ex-President Harrison and Commander-in-Chief Weissert. When General Harrison arose to speak he was greeted with a tre-mendous outburst of applause. In his words of welcome to the Grand Army he said: My Friends: It has been said that this is historic place. I remember when it was a fair ground: when the stalls along the east

side were filled with prize bullocks, when yonder stood the horticulturat hall in which the florists of the state displayed the triumphs of their art; when yonder stood the women's building, in which the deft and tasteful work of her fingers was displayed in kindly competition; while yonder the products of the farm and garden were heaped up to our admiring gaze. That was the time of peace. Our vocations had then to do only with peaceful things and our competitions

The vision changes; the bullock has given up his stall to the man; the products of the soil have given place to the best product of the American soil—its vigorous, brave, pa-triotic manhood. [Applause.] The flowers give place to guns and bayonets; the contests of speed about this track to that bloody contest in which the stake was a nation's life. I remember how the crowd of eager men poured into the city of Indianapolis to fill Camp Sullivan in response to Lincoln's call. I saw them pouring out from the trains as you have done today, only with a quicker step. I saw them come into these fields and put themselves under camp restraints and discipline, take guns into their hands and on these dusty fields and in the scorching sun of summer, that they might serve their country efficiently.

How slowly we grew to an understanding of the gigantic nature of the struggle; but with the growing knowledge there came a growing determination. With the growing demand for more men that came back to us from the front there came fresh hearts to respond and Abraham Lincoln could always hear the tramp of 500,000 more. [Applause. In the great struggle our state played in most conspicuous part. No Indiana soldier has been ashamed to open to the world, in friendly competition with the records of the

sister states, the story of Indiana's part in the great rebellion.

But the beauty of it all was that these regiments from Indiana and these from Illinois and Ohio were all one. They were not Indiana's soldiers, Ohio's or Illinois but soldiers of the United States. [Applause. The cause was one, the glory was one, and visiting comrades from other states, we are not here to exalt ourselves, but to take your hand and glory in the greatest result of war in history. [Applause.] If there is any man anywhere who does not admire the nion veteran, he does not live in Indiana. If there is any man anywhere who suspects him, or would detract in the smallest degree from the merits of his service, he is not here today. You will not see him on our streets. If there is anyone who can ever find it in his heart to speak ill of the wounded or disabled veterans of the war, or of the veteran

who has now fallen by the way after a brave struggle for nearly thirty years in the pur-suits of civil life, he does not live here. I look into the faces of men tonight who have shed their blood and lost their limbs and walked among us maimed and dismem-bered in order that our country's flag might be untarnished. Can it be possible that while the survivors of the great struggle are still with us, while they walk our streets, a generation has come on forgetful of their great achievements? Has the moth of avarice and the canker of greed so entered into the hearts of this generation that they are unmindful of these men? God forbid.

The American soldier of the civil war has not been greedy. He was not tempted to service by his monthly stipend. Men who wedt to the front were not impelled by sorwid purposes and when the war was overwedt to the front were not impelled by sordid purposes, and when the war was over
their thought was not of dependence upon
the government, but upon their own right arm.
Everybody who had been spared in the
struggle was anxious to be again at the
plow, at the shop, in the office, to take up
again the work he had laid down that his
country might live. As long as God gave
him strength of arm he fought to eat the
bread of independence. Only when he bebread of independence. Only when he be-came a veteran of time did he turn his hopeful eye toward the government for relief. The Grand Army has rightfully claimed that men who fell by the way in the battle of life from disease or advancing years and lost capacity to maintain themselves should be cared for by the nation they saved, and not be dependent upon the township poor farm. When congress, in generous recognition of the rightful claims of the soldier, has passed a raw for his benefit, we may and will demand that it be beneficially construed in his behalf. It is a familiar maxim of law that remedial legislation is to have a favorable interpretation in the interest of the evils to be remedied. Secondly, we may and do insist that, in the administration of law, the soldiers' integrity and honor shall not be wantonly impeached. [Cheers.] He will not ask that any who have fraudulently obtained place upon the pension rolls shall remain there. He will ask that that other familiar maxim of law, that fraud is to be proven and not presumed, shall be applied to the soldier. [Great apbe beneficially construed in his behalf. It is

Mayor Bemis Ignores the Urgent Request of Organized Labor.

HE VETOES THE SUNDAY CLOSING BIL

Whiskers Triumphant-Veto Sustained by the Council on a Close Vote-Hascall's Absence Causes Adjournment Early.

Mayor Bemis vetoed the pet measure of the journeymen barbers last evening. The

lows:

I berewith return without my approval an ordinance to Bregulate the closing of barber shops on Sunday for I consider this ordinance to be in the nature of special legislation, and that that the general law of the state sufficently covers all cases of uncessary work on Sunday. The ordinance not only declares it to be unlawful for any person to keep open any place of business on Sunday for the purpose of shaving or hair cutting, but also declares it to be unlawful to keep open any place on Sunday for doing any labor, work or business relating to or in any way consected with the office of a barber. Under this ordinance it would be unlawful to keep open a room or place of business for persons desiring the same, as providing baths is a business usually relating to and connected with the office of a barber. As to whether shaving or providing baths is a business usually relating to and connected with the office of a barber. As to whether shaving or providing baths is a vork of necessity is a question which can be determined only by courts a d juries. I do not consider that the council and mayor have the power or authority arbitrarity to declare any particular work as not being a work of necessity, neither do I think it wise to pass ordinances which relate only to special kinds of decessity, neither do I think it wise to pass ordinances which relate only to special kinds of mance, as a licady indicated, I consider that the general law of the state is sufficient to cover all cases with reference to which it would be proper to legislate by ordinance.

A large number of petitions and protests against the signing of this ordinance have been presented to me, which I herewith submit, for the purpose of enabling the clerk to place the same on file. I also submit a number of communications and petitions urging the approval of the ordinance. While I regret that I am unable to comply with the request of the petitioners last referred to, I see no other way consistent with my duty but to return the ordinance to your honorable body without my approval for such action as you may consider proper.

Bruner, Edwards, Elsasser, Howell, Jacobson, McLearie, Munro and Saunders voted to pass the ordinance over the mayor's vote. Messrs. Back. McAndews. Parker. veto. Messrs. Back, McAndrews, Parker, Prince, 'Specht, Steel and Bechel voted to stand by the mayor and the veto was sustained, as the necessary two-thirds vote to "override" could not be obtained.

The mayor also vetoed the items in the general appropriation ordinance granting Catherine M. Tussler \$660.25 and Louise Van Cott \$822.41 as judgments against the city on the judgment funds. These Items were paseed over the mayor's yeto by 13 to 2

city on the judgment funds. These Items were passed over the mayor's veto by 13 to 2. The mayor's veto of the bill of the Thomson-Houston Light company for June, on the grounds of violation of contract, was sustained by all the councilmen present.
