#### SLIGHT CHANGE OF POLICY.

A number of resolutions were introduced which provided for small expenditures in street repairs, each of which was made the subject of prolonged debate. It was con-tended that such legislation was contrary to the policy which was adopted at the be-ginning of the year, which was that no such expenditures should be made except by ordinance. The resolutions were passed, however, after some objection.

The committee on paving, curbing and gut-tering reported against the ordinance providing for paving Jackson stret from Thirty-sixth to Thirty-eighth with sheet asphaltum. The committee held that the property owners had petitioned for Trinidad sheet asphaltum and that such material should be used.

This revived the same old controversy that has played a part in nearly every council meeting since the Sherman avenue muss. Howell attacked the report, which he characterized as an attempt to prevent competition. Saunders defended the committee on the ground that the members had recommended the only safe method to insure the legality of

After further debate Howell's motion to amend the committee report in favor of the ordinanco was carried by ten votes to six. The amended report was then adopted, and the ordinance was subsequently passed. Ordinances were introduced carrying out

the recommendations of the finance commit-tee, relative to retrenchment. These were referred for consideration.

The following ordinances were passel: Pro-viding for repairing of Leavenworth street, from Twenty-ninth to Fortieth; changing from grade of Thirty-fourth street, from Poppleton avenue to Hickory street, and other streets; locating water hydrant at Twenty-fourth and Hamilton streets; ordering grading of alley between Thirty-fourth and Thirty-fifth, and Jones and Leavenworth streets; establishing grade of Thirty-fifth avenue, from Poppleton to Woolworth avenue. to Woolworth avenues.


