The Boecker home is a story and a half frame house and upstairs Henry and Lizzle lay on a bed with a bullet hole in their heads, the latter dead, the boy still breathing. In the opposite corner of the same room Caroline, Christine and John were dead, each with a bullet hole in the forehead, though Caroline had two.

Late this afternoon the bodies were still untouched, the sheriff and coroner being occupied in arranging for the inquest and other preliminaries. The inquiry will be other preliminaries, The inquiry will be oushed tomorrow by the coroner's jury. MURDER AND SUICIDE.

It is undoubtedly a case of murder and suicide. The indications are that Borcket first dispatched his wife with the shotgun, shooting her in the neck, then used the revolver on the baby, first shooting it and then knocking out its brains with the butt. Boecker then went upstairs, where the five children were sleeping and killed them. He must have used a light, for his aim was effective, each victim being shot in the fore head. All but two children met instant death, for the blood clots were under their heads and they lay as calmly reposed as it in sleep. All except Henry, who is not je dead, were attired in night robes. Boecker had reloaded the weapon while upstairs and evidently sent the second bullet into the oldest girl's brain just before leaving the room. Going downstairs he stretched himself beside the corps of his wife and sho himself. His right hand was burnt by the powder, showing the rapid use or the revolver. The weapon he had borrowed from his brother Henry last Thursday, remarking that he wanted it to kill rats in the cellar. It is now recalled that Boecker had since then practiced target shooting with it. BOECKER'S ANTECEDENTS.

Boecker was 34 years old, and for over twenty years lived in the same neighborhood; in fact, on the same farm. He has been regarded as a prosperous farmer and only recently bought a 200-acre farm a few miles from the old homestead. Yesterday he attended Catholic services with his family. Later he was visited by a neighbor who says that when he left the Boecker home in the evening they were seemingly a happy family and not a premonition of the awful tragedy enacted a few hours later was given by Boecker or any one of the household Members of his father's family say he had no family troubles, his financial affairs were in good shape, and they can assign no motive for the terrible crime. On the other hand, tt is said that John had disagreed with the old folks and Henry over the occupancy of the farm on which John lived and this is assigned by some as the cause of the trouble which culminated in murder and suicide. The family are Germans and highly respected citizens.

STORY TOLD BY WILLIAM CHARLES

Explains Why a Door in the Sausage Factory Was Barricaded and Why Caustie Potash Was Purchased.

He explained why, as he claimed, the caustic potash in which the body of Mrs. Louise Luetgert is alleged by the prosecution to have been dissolved, was bought. According to Charles' story the potash was purchased as the principal ingredient of a quantity of soft soap to be used in cleaning up the big factory preparatory to its sale to an English syndicate. The witness said he suggested this method of putting the factory in shape himself and that Luetgert, acting upon the suggestion, ordered a barrel of caustic potash weighing sausage factory. Lueiger, had let the man 375 pounds sent to the factory in March have a large amount of money and the last. This was about the time the defenseclaims the negotiations were pending between Luetgert and Davy, the mysterious Englishman, who is said to have represented the syndicate, and who borrowed something

CHASE FOR RATS. Charles also offered an explanation of the apparently barricaded door to the basement stairway by telling about a chase for rats in which a small dog was an active particlpant. He said that the factory had been infested by rats for some time and an effort had been made to get rid of them. The evening of April 30 he and Luetgert with others were in the basement, when a ter-rier, which belonged to the witness, got after a rat. Charles, Lucgert and the others moved boxes, barrels and other obstacles to aid the dog in his chase and the boxes and barrels were hurled in a pile against the door. The barricade of the door was unintentional, he said. It just here pened that the articles were thrown there
