SUPREME COURT SYLLABI.

City of Omaha against Bowman. Error from Douglas county. Reversed. Ryan, C.

With respect to water forming a pond on private property within the limits of a city, out on, or in dangerous proximity to a public highway, street or alley, such city owes no duty to the general public (aside from that of a sanitary character) other than such as devolves on private owners of property similarly situated even though the city may have created the pond of which complaint is made.
