> mercial museum. He was born in this city on December 27 1832, and with the exception of a brief period In his early manhood, when he conducted a commission business in Chicago, has lived here ever since. His father, Joseph Singerly was one of the originators of the street rail way system of Philadelphia, and William re-turned here to assume management of the Germantown Passenger Reilway company. iu 1877 he bought the Record, then a comparatively feeble journal, and brought it to its present standard of excellence. ORGANIZES A BANK.

In 1887, upon the retirement of Governor Pattlson from office, Mr. Singerly took an active part in establishing the Chestnu Street National bank, of which the ex-gov ernor became the first president. Upon Mc Pattison being called for a second time to the governorship of Pennsylvania, Mr Singerly succeeded him as president of the bank, and also become president of the Chest nut Street Trust and Savings Fund company.
In seeking relaxation from the cares of business, Mr. Singerly had for many years taken a keen interest in farming and stockraising. His herds of Holstein cattle at his farm at Gwynedd, in Montgomery county, were femous for years, and he was also owner of the Elkton stock farm, near Elkton, Cecil county.

Mr. Singerly was always an active demo-orat. In 1894 he was unanimously made the democratic candidate for governor of Penn-sylvania and entered with great energy into the cauvass, speaking in nearly every county in the state. In all he made over seventy speeches in upholding the cause of democracy. The natural republican majority of Pennsylvania was too great to be overcome, however, and his competitor, General Hast-

During the last national campaign he supported the Palmer and Buckner ticket, mak-ing a number of speeches in its behalf in Pennsylvania, Delaware and Maryland and organizing a local association in aid of the movement. He also took an active part in forming the Pennsylvania Bankers' asso-

Financial misfortune overtook Mr. Sin-gerly during the last few months of his life, gerly during the last few when on December 23 last the Chestnut Street National bank and Trust company were compelled to close their doors. Messrs Earle and Cook were made assignees of th trust company and managers of a plan look ing to the liquidation of the affairs of both institutions. Mr. Singerly promptly turned over to them every personal asset he pos-sessed, including his interest in the Record Since then a receiver has been appointd for the bank and the affairs of it and the trust company are in process of settlement.

Poet Frederick Tennyson. LONDON, Feb. 27 .- Frederick Tennyson he poet, eldest brother of the late poe laureate, Lord Alfred Tennyson, died yesterday. Frederick Tennyson, who was eduated at Eton and Trinity college, Cambridge, early developed a gift for verse, and in 1828 won Sir William Browne's medal for a Greek ode in the Sapphic metre on the subject of Egypt. In his early years he traveled extensively in the Ionian islands and in Sicily and he lived for some time in Flor-ence and Piza. From 1859 to 1895 his home was in the Island of Jersey, but for the last two years he had frequently sojourned at Kensington, London. Among his best known publications are "Days and Hours," "Daphne and Other Poems," "The Isles of Greece (Sappho and Alcaous)," and "Poems of the

Hobart Brush. ASHLAND, Neb., Feb. 27 .- (Special Telegram.)-Hobart Brush, one of the best known and respected citizens of Saunders county and senior member of the firm of Brush Bros., druggists, of Ashland, died at his ome in this city at 7 o'clock this morning from nervous prostration, caused by overwork, aged 58 years. Mr. Brush was born in Buffalo, N. Y. He came to Nebraska from Wisconsin in 1864 and has been one of the most prominent citizens in this section of the state. When Saunders county was organized in 1866 he was elected the first county clerk. He was a brother of Marcus Brush, well known all over Nebraska in the '60s. He leaves two sons. daughters and two brothers, L. R. Brush of Ashland and Eugene Brush of Omaha.



For years we have encouraged players to adopt rough tactics in our eagerness to win games. One club began it and others were forced to follow. The fining by umpires was but a sham, as the club owners paid the fines. Now, after we have raised these players in this way, some of the league magnates propose that, in order to wean them of their bad habits, we give umpires the power to have them blacklisted for a violation of the new regulations. This is entirely unjust. The club owner should share the punishment, because he is more guilty than the player.

I shall take the stand at St. Louis that for the first offense a player be 'suspended thirty days without pay. That is a severe punishment for him, and he would not care to take a chance 'on losing another thirty days' pay. At the same time it is a punishment for the owner, who loses the services of a valuable player for thirty days.

I believe that the rule placing so much power in the umpires' hands is extremely dangerous. They are just as apt to 'go off the handle as a player and vent their spite on the players they do not like.
