# WAS ADAIR WITH RAY HORNE

Question Being Heard in Police Court Before Judge Gordon.

IDENTITY OF DEAD BURGLAR'S PARTNER

Circumstantial Evidence and a Deathbed Confession to Connect the Prisoner at Bar with Robbery of Farnsworth's Store.

The case of Lowell Adair, alleged to have been the burglar who escaped when Roy Horne was shot in the act of robbing Samuel H. Farnsworth's cash register, was opened in police court yesterday afternoon and a mass of circumstantial evidence was brought to connect him with the crime. When the shot was fired a companion of Horne's made a plunge through a plate glass window and escaped, leaving on the sidewalk a soft, red hat as the only clew to his identity. This evidence, together with a heavy piece of iron employed to break into Farnsworth's window, is used in connection with Horne's dying confession to connect Adair with the crime.

The first witness was Samuel H. Farnsthe night of August 31. He said he had retired at 10 o'clock in an alcove partitioned from the store proper. About 1:30 o'clock he was awakened by the sound of some one working at a rear window and a few minutes later heard the intruder enter and state with the exception of one witness and speak in a low tone of voice to a compan- the case was continued until S p. m. today. ion. He was able to distinguish the word. 'wait," and then as the men passed his door he arose and softly turned the lock. He secured his revolver from a drawer and drew the shade back from the glass of the door. He could see the form of a man at work at the cash register and without hesitation he fired through the glass. The robber staggered in the direction of his companion, who at that moment made his sensational dive through the front window. The druggist saw the wounded burglar fall and running through a side door he started in pursuit of the fugitive. The latter fled north on Twenty-second street and disappeared in the rear of the Glencoe mills Farnsworth then returned and found the injured man lying near the door, "I got you that time, old man," he said, and the robber responded. "That's what you did. partner." The druggist plied Horne with red hat as one that he found on the sidewalk immediately after the occurrence.

What Other Witnesses Know.

A. W. Tidd, 524 North Twenty-third street, gave an important bit of circumstantial evidence regarding the piece of iron which he had found under a wagon box in the rear of Adair's house. It was very rusty, but had the appearance of recent use and after Tidd had been shown the marks of a jimmy on Farnsworth's rear window it occurred to him that the shape of the iron was similar. He took the bar to Farnsworth's store and together they fitted it in the marks on the door and window. It filled the indentations exactly, the mark of a flange on one side being perfectly outlined. On the night of the occurrence Christ Johnson, living in a house adjoining Adair's at 2023 Cuming street, testified that he had heard two men talking over the high board. fence which separates the two yards.
