NOTICE OF AMENDMENTS OF ARTICLES OF INCORPORATION. The Bee Publishing Company has amended its articles of incorporation in the office of the secretary of state, and also with the county clerk of Douglas county, Nebraska, and by virtue of said amendments articles of incorporation of said company have been amended.

ARTICLE I.

The undersigned do hereby associate ourselves together as a corporation under and by virtue of the statutes of the state of Nebraska, by the name and style of THE BEE PUBLISHING COMPANY.

ARTICLE II.

The principal place for the transaction of the business of said corporation shall be in the city of Omaha in the county of Douglas and state of Nebraska.

ARTICLE III.

The general nature of the business to be transacted by said corporation shall be to print and publish daily, semi-weekly, weekly, newspapers and magazines; to operate a printing plant; to purchase and sell printing materials; to publish, book binding, engraving, lithography and general printing, including printing, printing stock and newsprint.

ARTICLE IV.

The authorized capital stock of said corporation shall be five hundred (\$500,000) divided into shares of five dollars each, and of the number of shares of said stock that shall be issued in excess of the number of shares of said stock \$100,000.00 shall be authorized by a vote of the outstanding stock of said corporation, and provided the same shall be sold or issued for less than par.

ARTICLE V.

The time of commencement of said corporation shall be the first day of January, 1900, and the date of termination of the same shall be the first day of January, 1905, unless renewed or dissolved sooner by a vote of two-thirds of the capital stock thereof.

ARTICLE VI.
