Lands in the "n'utral strip" are to be reserved for location by settlers on those lands for thirty days.

## Location of Townsites.

Provision is made for locating townsites. Townsite applicants are required to file before the opening of the lands a "written application to that effect, describing by legal subdivisions the lands intended to be affected and stating fully and under oath the necessity or propriety of founding or establishing a town at that place." Other restrictions for townsites are as

follows: "The local offices will forthwith transmit said petition to the commissioner of the general land office with their recommendation in the premises. Such commissioner if he believes the public interests will be homestead entry and settlement, and directing for townsite settlement, entry and disment, entry and disposition under the gengeneral townsite laws except in the manner herein prescribed until after the expiration of sixty days from the time of said opening."

The future disposal of lands is provided for as follows:

"After the expiration of the said period of sixty days, but not before, any of said lands remaining undisposed of may be setsettlement, occupancy and entry had not been prescribed herein in obedience to law."

Injunction Suit Against Register of Land Office to Stop the Homesteaders' Rush.

KANSAS CITY, July 7 .-- A special to the Times from Oklahoma City, Okl., says: An injunction suit will be brought be fore Judge Irwin at El Reno in a few days for an order restraining the register of the land office here, the receiver, the surveyors and all other persons from proceeding with the opening of the lands of the Klowa, Comanche and Apache Indians according to the proclamation of the president and the act of congress under which he proceeded. The suit will be brought C. Porter Johnson of this city, who been engaged by Judge William Springer to act for the Indians. The bill ulars is being prepared and action on it will, if taken, prevent the registration of lands in the reservation. If there is a court of law with jurisdiction at Lawton the case will be commenced there in a similar manner. The bill of particulars will contend that the lands of the Indians are being illegally and unconstitutionally wrested from them against their wishes. It will show that the organic act constructing the Indian territory made the laws applicable to the territory. Provisions were made in the act whereby the Indians could invoke the aid of the courts for their protection.
