CITY COUNCIL PROCEEDINGS that adopt

Mayor Submits Communication Relative to Asphalt Repair Contracts.

SHOWS WHERE SAVING MAY BE MADE

Communication is Read and Referred to the Board of Public Works-Budget of Routine Business is Dispatched.

At last night's meeting of the city councli Mayor Moores urged the councilmen to investigate the asphalt repair contracts which are about to expire and to take advantage of contracts under which repairs sustained on a Pierce street sidewalk. can be made at less cost than under the contract for the present year. The mayor's communication to the coun-

At this time, when the public is so deeply interested in the question of repairs to asphalt paved streets, I desire to call your attention to a matter which may have been overlooked by you and the engineering department of the city.

On March 12 1829, the city entered into a contract with the Barber Asphalt Paving company whereby the company contracted to maintain the asphalt pavement in good condition in forty-six paving districts upon which the original guarantee had expired, or was about to expire, this agreement to be for a period of ten years from the date of the expiration of the original guarantees. This ten-year period expired on thirty of these districts during the years 180s, 1838 and 1899 and will expire on five districts in the year 1801. The number of the districts, the names of the streets and the date of the expiration are as follows:

as follows:
Paying district 43, Jackson street from Ninth to Thirteenth, expires August 9, 1891.
Paying district 44, Tenth street from William to Center, expires October 19, 1801.
Paying district 52, Eleventh street from Howard to Jackson street, expires August 2, 1881.

Paving district 35, Capitol avenue from finth street to Fourteenth street, expires ingust 26, 1961.

Paving district 15. Capitol avenue from Ninth street to Fourteenth street, expires August 25. 1961.

Paving district 16. Twenty-fourth street from Cuming to Seward street, expires December 8. 1961.

There are eight more districts where the guarantee expires in 1962 and three more where the guarantee expires in 1963. All the above facts and figures, with additional information, can be found upon pages 319 and 311 of the annual reports of the city of Omaha for the year 1983 in that part of the report compiled by the city engineer, Mr. Andrew Rosewater.

It will be seen from the foregoing statement that the contract on district 52 expires August 2, on district 52 August 3 and on district 55 August 38. I call the attention of your honorable body to these facts for the reason that I am informed by various parties that the pavements on these streets are not in good repair, as called for by the contract, and that there are numerous holes in the pavement which need attention. If your honorable bedy and the Board of Public Works will take immediate steps to notify the Barber Asphalt Paving company by proper legal notice that these streets need repairs and that the city will refuse to pay the amount specified in the contract unless they are repaired, the company will be compelled to repair these streets, provided the notice is properly given it before the expiration of the respective periods of guarantee, the first of which expires August 2. Prompt aution will therefore be necessary if it is to avail anything.

The contract with the Barber company on these streets provides a yearly payment by the city for repairs of 8 cents per square yard for all the surface within the paving districts, whether any repairs are made or not. The amount of this charge for 191 amounts to about \$5.550. The contract is a very one-sided one in favor of the asphalt company and the city should compel the company and the city will have to pay the bill, no matter whether the streets are in bad condition or not.

this connection. In the year 1896 the city entered into contracts for the repair of asphalt pavenents on sixty additional paving districts. Of these the Barber Asphalt Paving company procured a contract for fifteen districts. Hugh Murphy for one district and John Grant for forty-four districts

The Barber and Murphy contracts expire August 4, 1991, while the Grant contract expires September 29, 1991. By these contracts the city agreed to pay prices ranging from 98 cents to \$1.10 per square yard, based upon the amount of repairs actually made. These various facts are set forth in the city engineer's report found in the annual report of the city of Omaha for the year 1896, on pages 177 and 178. The city engineer in his report states that this price is the lowest rate obtained for this class of work by any city in the United States and it was only secured by the bitter competition which at that time existed between the competing contractors. These contracts cover repairs on streets which have been more recently paved than those covered by the ten-year maintenance contract with the Barber company mentioned in the beginning of this communication.

Now, my suggestion at this time is this: hat if there are any of the streets within these sixty paying districts which need small repairs the city should at once notify the three contractors to make such repairs under these contracts, because the contract which has recently been let for repairing is at a rate 25 per cent higher than the rate obtained under the contracts of 1896 and the city will save several thousands of dollars on repairs if made under the 1896 contract instead of under any new contract which might be obtained.

Your honorable bedy will notice that the Barber contract and the Murphy contract, covering sixteen districts, expire August 4, so that whatever notification is given to these companies must be given prior to your next regular meeting, which occurs August 6.

The repairs suggested are on streets where the pavements are in good condition and repairs are small and none of the districts covered by these contracts is in similar position to North Sixteenth street, where the pavement is entirely rotted out and where the city has already kept the pavement in repair for more than thirteen years at public expense at a cost of over \$20,000. Such streets should not be repaired and there is none of that character covered by the three contracts to which I have called attention.

TROUBLE IN THE PHILIPPINES

How the United States Military Government Deals with Violators of the Law.

Copies of several reports made by commanding officers of the United States army in the Philippines have been received at the Department of the Missouri headquarters in this city.

The first interesting report details the trials of alleged "pacificos" taken in arms against the government, or of men entrusted with office by the United States trust reposed in them. One of these was of Moncada. Shortly after his election he was found in correspondence with an insurgent officer and had issued an order to yard. all able-bodied men to organize themselves as insurgent soldiers and receive arms treason by Nicholas Valenton, the vice president. They were tried and found guilty, sentenced to thirty and twenty years' imprisonment at hard labor, rethe reviewing officer to twenty and ten years, respectively.

Oracon, a Moro of the island of Mindanao, is reported to have been sentenced for murdering a Spaniard and his native serv-

The military courts, when guerrillas are arrested, try the officers for murder when it can be ascertained that the band has been guilty of murder and rapine. Several such officers have been sentenced to be hanged, while their followers have been sentenced to imprisonment.

In the trial of Juan Aganon, a native, the American officers found the existence of a secret society among the natives, having for its object the expulsion of the forces of the United States. The society is known as the Kalipunans and exists in the island of Luzon. Aganon was found to be a member of the society and in committing the murders for which he was sentenced to be hanged he but carried out the orders of the lodge to which he belonged. The court-martial in passing sentence upon him referred to the Kalipunans as a society which must be disorganized before the complete pacification of island can be accomplished.
