Judge Estelle yesterday granted the temporary injunction applied for by Charles Karbach to restrain the performance of the contract for repairing the street awarded to the Grant Paving company by the Board of Public Works and approved by the counell over the mayor's veto.

My decision in this case," said Judge Estelle, "is based on section 77 of the charter, which prohibits the council from taking final action on a proposition that involves an expenditure of the public funds without first having the certificate of the comptroller that the funds are available for the particular purpose. I don't believe the council has any right to enter into a contract unless the funds are available, and the only evidence of this would be the comptroller's certificate."

Based on One Point

Having decided the case solely on the one point-the absence of the comptroller's certificate-the court did not pass upon the question as to whether the condition of the pavement was susceptible to repair, but Judge Estelle remarked that in his opinion that was a question for the city council to determine.

Councilman Hascall, who was in court when the decision was announced, remarked to the judge:

"Why, all of the contracts for city supplies have been let by the council without having the comptroller's certificates that funds were available for the payments. Are such contracts also invalid?" "That question is not before the court,"

GOES AFTER COLLEGE PAPERS

Business Education Pamphlets Ar First to Come Under Ban of Government Inspection.

The first newspapers in Omaha to fail under the ban of the postoffice department under the terms of the recent order of Postmaster General Smith are the business college publications. Coincident with the publication of the order the publishers of these papers received notice to file with the assistant postmaster general reasons why their publications should not stricken from the list of publications entitled to be rated as second-class matter. A day or two ago the reasons were filed and forwarded to Washington. In the meantime no issue of the publications will be published, although under the ruling of the department they would be entitled to second-class privileges until such time as a

final decision is reached by the department. The postmaster general has just issued an explanation of his recent order affecting second-class matter and this explanation upholds the petition of Assistant Postmaster Woodard, who when the order was first received said that he believed that it would cause newspapers to discontinue the practice of offering prizes to subscribers and inducing subscriptions through guessing contests, for the third paragraph of the explanation distinctly mentions guessing contests as one of the practices which must be discontinued in order to entitle newspapers to remain on the list of second-class mat-

In the explanation the time of the enforcement of practically all of the provisions of the recent order is extended until October 1, but at that time all publications must comply with the terms or be debarred from second-class privileges. Newspapers and news agents starting business before October 1 must comply with all of the provisions of the new regulations, so they will be at a slight disadvantage compared with older concerns during the months of August and September.




