He received 567 votes and Fred Beckman, his nearest competitor, seventy-one votes.

OWNER SKINS ONE AND HOGS EAT CARCASS

Cuts a Finger in the Operation and it is Feared that He, Too, May Also Be Stricken.

PENDER, Neb., Aug. 15.—(Special Telegram.)—Fred Smith, a farmer one mile from Fred Gilster's, lost four head of cattle from anthrax. Mr. Smith did not realize the fearfulness of the disease and skinned one of the cows. He let his hogs have the carcass and inside of two hours forty-five hogs were dead. His big dog ate a portion of the carcass and died in a few minutes.

A part of the skull, about two or three inches, at the top of the head was removed, together with a portion of the brain. Several pieces of bone were picked out of the brain, but the lad has recovered the full use of his limbs and his speech. He is sound of mind and is believed to be able to make a livelihood for himself, but he will be unable to withstand much sun heat. The boy's parents are poor and the county is taking care of the case. A subscription was taken in this city to aid Miss Merno of Doniphan, who had a limb broken during the storm of that day. She has also been taken care of at St. Francis hospital by the county.

SUPERVISOR BULLOCK IS IN CHARGE

Million Acres Divided into Twenty Precincts—First Man at a Blaze is Chief Tilt Ranger Arrives.

DEADWOOD, S. D., Aug. 15.—(Special.)—Captain Seth Bullock of this city, the new forest supervisor of the Black Hills, has organized the largest fire company in the world. Every member is giving his services without pay, yet is expected to be on duty constantly. Some time ago the secretary of the interior department made an order permitting people to graze cattle on the forest reserve to the full limit of 7,000 head for the million or more acres. A man can have four or less head without asking for a permit, but beyond that number, to a limit of 120, he must ask permission of the supervisor, showing that he has the proper range and that he intends to comply with the law.
