Mr. Bmyth replied to General Cowin's argument briefly and with considerable fushing. He agreed with the general that unintuful acts should not be permitted. and he said: "We want unlawful acts restrained. What we want is that they shall not be restrained from deing lawful acts. We do not want this court to take sides. If a man can be restrained from persuading, then these 5,000 men can be restrained. from surflying. That is not the law. When the packers reduced the price of live stock. they did not think of the farmer. With their overwheiming wealth and power they can defy and paralyze the law. No court has put forbidden the 'picket' but has had its depicton payers. A law should be certain as well as just. Give us an order forbidding us doing any illegal act and we will obey?


