**Newberry Target** Of-Broadside by Senator Kenyon

"Entire Election Tainted," Declares Iowan in Fiery Senate Speech-"Rule of the People Is Gone."

Washington, Dec. 21.-Declaring the money spent in Senator Newberry's campaign for election to the sen-ate from Michigan shows the "en-tire election to be tainted," Senator Kenyon, republican, Iowa, asserted in a speech in the senate today on the Ford-Newberry election contest that if that body voted to seat the Michigan man it would be "under-mining the foundations of this govcrnment.

"The rule of the people is gone," Senator Kenyon said, "if the senate justifies the expenditure of hundreds of thousands of dollars to secure a seat here."

While the federal act limiting campaign expenditures has been declared unconstitutional by the supreme court since the Newberry campaign. the senator declared it was in effect at that time, and so, he added, "we find the common laws, the federal statute and the state statutes violated, the latter openly, notoriously so." The record shows an expendi-ture of "at least \$263,000," Senator Kenyon said, adding that "the plain inference from the testimony is that a much larger sum was expended."




