## TO MEET THE REDS

Team Leaves This Morning For Kansas City.

The Prospects Are That a Large Crowd Will Follow.

The team will leave this morning at 11:55 over the Burlington for Kansas City, and the excursion train will leave twelve hours later. A four dollar rate should take every enthusiastic Nebraskan down to cheer for the varsity. For the ladies who wish to take advantage of this rate tourist sleeper accommodations have been provided. The return limit on the \$4.00 tickets is Saturday evening, on the \$5.55 rate the limit is Sunday evening. The enthusiasm manifested at mass meeting yesterday morning wasn't up to the usual standard. This game tomorrow is going to be a stiff proposition. We will win, of course, but there should be a big crowd on hand in Kansas City to share in the victory. The team will be quartered at the Midland hotel, in Kansas City, and this hotel will be made Nebraska headquarters. Seats can be had from Manager Davis there any time before the game Saturday. The price of admission has been placed at \$1.00 for any seat in the grounds. Seats of course, will be reserved, but no extra charge will be made for the reservations. \$1.00 for the big game, \$4.00 for railroad fare, and \$1.50 for meals making a total of not more than \$7.00, ought to be an inducement for a big crowd to go down. Add to this the opportunity of seeing a royal game, and the pleasure of this trip, and \$7.00 is merely nominal.

All things being equal Booth would rather coach Nebraska than any other team. He has made football here, and has maintained it. His is a just pride in his pupils and their achievements, and he would be loath to leave them. Nowhere could Nebraska secure a man who combines qualities that fit him eminently for our coach as does this man Booth, and we simply can't let him go.

The above report is further discredited on account of the fight which is now being waged at Wisconsin against professional coaching. It is probable that the Badgers will soon adopt the graduate system of coaching, since there is a strong sentiment prevalent for it already.

### ANOTHER GAME OFF.

Beatrice High School Cannot Play Academy Today.

The football game between the Lincoln academy and Beatrice high school scheduled to be played in Beatrice today was called off by the Beatrice management yesterday. The Beatrice athletic grounds are situated in a ploughed field and the snow put them in such a soggy condition that the Beatrice management felt compelled to cancel the game. The Beatrice team is one of the strongest in the state this year and the "preps" feel very much disappointed over not being able to test their strength against the high school men. One of the most striking things about the academy team is the rapid development which it always makes during the last few weeks of the season. Supporters of the team consider it to be much stronger now than when it played Omaha high school two weeks ago, and they have looked forward to a good game with the Beatrice men. The same rapid development was noticed towards the end of the season last year. This the academy men claim is due to the fact that they have no second team. They have not in the history of the academy been able to get out more than sixteen men for regular practice. The present management has found it much more difficult to build up a team this year because of the lack of the Lincoln Medical students who had their chemistry work in the academy last year. Since they have no scrubs they get all of their football experience in the games and hence take a brace after a few games have been played.

Agricultural Students Will Make Good Soldiers.

Wednesday afternoon two new military companies were organized at the state farm to be known as Company "E" and Company "F," with a combined membership of 191. This will probably be increased to about 110 or 115 before registration closes at the end of this week.

The new cadets will drill four hours per week, with an additional hour for recitation. The men seem to be taking hold of the work with unusual spirit, and prospects are excellent for a high grade battalion.

The battalion will be officered by four men on the university battalion staff until sufficient proficiency is attained by some of its own members. It will take part with the university battalion in all regimental drills, and will probably be entered in the annual competitive drill next spring.

### WHITE WILL COME.

Noted Single Taxer to Speak at University.

Hon. John Z. White, of Chicago, the noted single tax lecturer will speak at convocation Monday morning, and will give a lecture Monday evening on the single tax. The time and place of the second talk will be announced in tomorrow's Nebraskan and by bulletins.

Mr. White is general lecturer for the National single Tax league and has delivered lectures for several years in all parts of the United States.

He is said to be a most interesting and entertaining talker.

### Play High School.

Enough men turned out to basketball practice last night to use both floors, and consequently everybody got in the game for some time. The practice was good and swift, but many shortcomings can be noticed. Inability to hang on to the ball, and inaccuracy in goal throwing are the worst faults at present, but these will disappear with further practice. A game is being arranged for next Thursday in the gymnasium. This will be the first opportunity the men will have to line up against an outside team, and the game will be a good one for their practice, as the high school usually turns out good basketball material. The match will be merely a practice game and no admission will be charged. It is expected to show up what may be looked for from the team this year.

## ATHLETIC RULES

Inter - Class Board Announces New Regulations.

Standing of The Laws Defined.—The Constitution.

The following are the rules which will govern inter-class athletics for this year, as announced yesterday by the inter-class athletic board. The constitution, which is also published below, has been altered somewhat:

I. With the exception of students paying only law tuition, who are eligible for law teams only, any bona fide student of the university excepting as hereinafter provided, is eligible for academic teams and shall be classed as follows in rule 2:

II. The former shall be classified as follows:

(a) Any student having less than thirty hours credit shall be considered a freshman.

(b) Any student having between thirty and sixty hours credit shall be considered a sophomore.

(c) Any student having between sixty and ninety hours credit shall be considered a junior.

(d) Any student having between ninety and 125 hours credit shall be considered a senior.

The classification of the law students shall be determined by the managers of those teams.

III. No student who is on the varsity squad in the 1904 season shall be eligible for football teams, and no student who has played any part of a game on the varsity shall be eligible for basketball teams.

IV. Each manager shall hand a list of his players to the opposing manager two days before a game, and in case of protest, it shall be determined by the chairman of the four committees not interested, the vote of three being decisive.

V. The teams shall be paired off as follows in football and basketball: Freshmen-Sophomores, Juniors-Seniors, Winners-Winners; Freshmen-Law-Junior Law, Winners-Senior Law; Winners of the Academic championship vs Winners of Law championship. The last game shall determine the championship of the university.

VI. By mutual and express agreement any two teams may play unofficial games not subject to board control, and not counting in the championship, but any game not played with this express agreement shall be considered official.

VII. By mutual agreement any contest in the basketball series may consist of three games, the winner of two to be winner of the series. All such games shall be official and under board control.

VIII. Any game ending in a tie, other than the final game, must be played off, and any team refusing to play shall be defaulted. The managers of the two teams may agree to divide the money and championship in case of a tie final game, but either manager may demand a play-off.

IX. The interclass board shall collect and control the receipts of all official games, and at the end of the series shall award the entire amount above expenses to the winning team, which shall have the absolute right of disposal in it.

### CONSTITUTION.

1. The inter-class athletic board shall consist of three members of each of the academic classes, and one member from each of the law classes, such members to be appointed by the presidents of the classes.

II. Each member shall have one vote, and the unit rule shall not prevail. Eight members shall constitute a quorum and a majority vote shall rule in all cases.

III. The chairman of the senior committee.
