MR. SHEDD AND MRS. CLARK RE-SIGN POSITIONS.

Regents Meet at North Platte in Special Session. Report of Business Transacted.

A special meeting of the board of regents of the University of Nebraska was held on Tuesday at North Platte, all members being present except Regents Allen and Teeters. The particular object and business of the session was the inspection of the three sections of !and constituting the substation farm at that point, the experimental work in progress, the selection of sites for superintendent's house and office, new barn, and other permanent improvements, the remainder of the appropriation to be used for maintainance chiefly and live stock. The building committee was instructed to report to the board a recommendation of the amount required for each of the proposed improvements. The superintendent of the farm and the director were instructed to proceed immediately with minor repairs to fences and to the dwelling house on the west half of the tract.

The resignation of Mrs. Virginia H. Clark, secretary to the Chancellor and assistant registrar, was accepted, to take effect June 1, 1905. Miss Emily Guiwitz was appointed to have charge of the teachers' bureau heretofore managed by Mrs. Clark.

The resignation of Mr. H. G. Shedd, registrar, was accepted, taking effect May 15, 1905. Mr. Shedd has accepted an important position with a company conducting a private business en-

Mr. E. H. Clark, recently chosen as purchasing agent, was appointed regis-

lating to organization of debating and five student members, as follows: publishing boards:

Student Publications.

"First-A student publication board is hereby established, to which the supervision and control of all student periodicals, except annuals and year books, is hereby delegated.

"Second-Said board shall be composed of five faculty members and three student members. The faculty members shall be heads of departments, appointed by the chancellor and the board of regents. The student members shall be upper classmen in good standing, and shall be elected annually in such manner as said board shall prescribe.

"Third-No person shall be eligible to be the editor of any student publication within the jurisdiction of said board, unless he is an upper classman in good standing and has shown such skill in English composition as to pass with credit in the department of phetoric at least the course required of all students.

"Fourth-No person shall be eligible to serve as reporter or regularly contribute to any such publication unless he has shown such skill in Boglish composition as to pass with credit in the department of rhetoric at least the courses required of all students.

"Fifth-All editors, associate editors, business managers and assistant so greatly crowded.

managers of such publications shall be appointed by said board.

"Sixth-Said board may, at its discretion, regulate the business management of any such publication.

"Seventh-Said board may make such rules or by-laws, not inconsistent herewith, as may be required in its judgment, such rules or by-laws to be submitted to the Chancellor for ap-

"Eighth-The department of rhetoric may, in its discretion, give credit for suitable work done by students upon publications under the jurisdiction of said board.

New Debating Board.

"First-The debating board, as at present constituted, is hereby abolished, and a new board is hereby created, as follows:

"Second-The name of the board hereby created shall be 'The Debating Board of the University of Nebraska."

"Third-Said board shall have power and it shall be its duty to take full and complete control of and to regulate all public debates between students of the University or representatives of student organizations therein and students of other institutions of learning or representatives of clubs, societies, or like organizations in other institutions of learning.

"Fourth-Said board shall be com-The following rules were adopted re- posed of seven faculty members and

"Fifth-The faculty members shall be the professors of rhetoric in charge of the course in argumentation and debate, the professor of American history and politics, the professor of Eurepean history, the professor of political economy and public finance, the professor of sociology, the professor of philosophy, and the professor of jurisprudence and public land, and their successors respectively.

"Sixth-The student members shall be chosen annually in such manner as the board shall prescribe. No student shall be eligible to membership on said board unless he is an upper classman in good standing and has pursued with credit one or more courses in argumentation or debate in the department of rhetoric.

"Seventh-The University accountant shall be ex officio treasurer of said

The Freshmen will have some strong men and should at least land second place. Some of the most prominent men of this class are: Burruss, Wallace, Davis, Cornell and Peck.

The damp weather this week will prevent the men who participated in last Saturday's meet from making much improvement, but the men out for the first time this year will get a chance to show what they can do. Among these will be Manning, States and Havens. Manning is well remembered by the track enthusiasts from his remarkable performances in the dashes two years ago. States has been a member of the team ever since he entered the University, and many times he has added five points to our score. Last year he found a good running mate in Havens, whose performances in the Minnesota meet and at Chicago are sufficient testimony With these men, and as to his worth. the all ready fast team Nebraska should not take a back seat for any one in track athletics.
