PICTURE OF FORMER DEAN RICHARDS WILL BE PRESENTED BY SIGMA TAU.

At convocation hour this morning in Memorial hall a program will be given by students and members of the faculty of the Engineering College. This will be one of the important features of Engineers' Week. The committee has announced that there will be a special section reserved for engineers.

The engineers' quartet will give several appropriate songs. Probably the most important number on the program will be a presentation to the Engineering College by Sigma Tau, the honorary engineering fraternity, of a picture of former Dean Richards, now at Illinois University. The picture will be accepted by Chancellor Avery, as acting dean of the college. Prof. O. V. P. Stout will give a recital of the history and statistics of the growth of the college.

"JERRY" SMITH IN CITY

IS ONE OF NEBRASKA'S OLDEST AND MOST SUCCESSFUL BOTANY STUDENTS.

J. G. Smith, '88, otherwise known as "Jerry" Smith, passed through Lincoln yesterday on his way to New York City. Mr. Smith is one of Nebraska's oldest botany students, having been in the first class to use microscopes. He was also a charter member of the Sem. Bot.

After receiving his degree, Mr. Smith was connected with the Nebraska experiment station. His chief work there was experimenting with Nebraska's wild grasses, of which he gathered the seeds and demonstrated for the first time which grasses were best to cultivate.

When M. Smith left Nebraska he went to Europe, where he studied in a German university. On his return he stopped in Australia, Japan, and Mexico, in which he made botanical trips. Returning to the United States, he came to Nebraska and took his master's degree in 1892. After finishing his school work he went to Washington, but was there only a short time until he was sent to the Hawaiian Islands. There he established the first government experiment station. After a few years in this work he went to Honolulu and entered into a very successful private business.

Mr. Smith was in Lincoln only a few hours, but expects to return in about two weeks. At that time he will make a much longer visit.

HUGE CROWD AT BURLESQUE

UNIVERSITY NIGHT SUCCESSFUL FROM STANDPOINT OF THE PERFORMANCES.

University Night, successful from the standpoint of the performances, was marred by the crowded condition of the Temple theatre and by the failure to keep faith with the announced intention of not opening the theatre doors until the close of the Nebraska-Kansas basketball game. An enormous crowd witnessed the burlesque, one, in fact, that demonstrated forcibly that in the future larger facilities must be secured for the affair.

The program consisted of eight numbers. The first of these was a selection by the Mandolin club. The next was an original one-act playlet written by Dana Van Dusen. It was presented by a cast of four. The Glee club rendered two selections. Among the parodies were "A Faculty Meeting," by the Palladian and Union societies; "Doc Lyman's Drug Store," by the Medics; "Down on the Santa Fe," by the Engineers; "A Farmers' Institute," by the agricultural students, and "A Picture of Rush Week," by the various fraternities. Of these, the engineers' performance was quite the best.

The affair was under the auspices of the Y. M. C. A. and was in charge of a committee of which Verne Bates was chairman.

TEAM FINISHES SEASON WITH SPOTLESS RECORD

CORNHUSKERS BEAT KANSAS IN LAST OF CONFERENCE GAMES.

JAYHAWKERS ASK FOR ANOTHER TRIAL

They Insist on Series of Three Games to Decide Championship of Valley.

By winning from Kansas Saturday night, the Nebraska basketball team established a new record, that of not being defeated by a conference team during the entire season. And yet Kansas insists on a championship series, Manager Hamilton stating that Kansas is still in the race and has hopes of overcoming the four defeats handed it by Nebraska. Just where the three games will be played has not yet been decided. Manager Hamilton desires to have one game played in Lawrence, one in Lincoln and the third in Manhattan, while Manager Eager wants one played in Lawrence, one in Kansas City, and if a third is necessary, to have it staged either in Lincoln or Omaha.

Saturday's Game Close.

Nebraska, using only one regular at the beginning of the first half, finally nosed Kansas out, by substituting its regular team and a "bleacher" substitute, by a score of 29 to 28. The game as a whole was entirely unsatisfactory, being marred by rough tactics of the visitors, incompetent work on the part of the referee and interruptions by the audience, which were in part justifiable.

Haskell and Brown Star.

Haskell for Nebraska and Brown for Kansas were the stars of the evening's contest, especially in scoring baskets. Haskell getting four while Brown made five, which with eight free throws made over half the points scored by his team. Carrier, Frank and Hiltner played stellar games and were responsible for overcoming the lead established by Kansas in the first half. Of the substitutes, Hyde played great ball, but was unfortunate in not being able to locate the basket. Kavan made his first appearance in a Cornhusker suit, being called from the bleachers when Nebraska ran out of substitutes near the end of the second half, and played a good game for the time that he was in.
