Tecumseh put up a plucky fight, but was clearly out-Townsend and Stewart showed up well for Tecumseh, while Collins and Menefee were the individual stars for South Omaha. Central City next won a hard contest with Wahoo, taking the game by a score of 19 to 15. Hamilton of Wahoo played a great game and with better support would have shaded Central City. Kerr and McDonald of Central City played the best game for their team. Beatrice, playing an easy game and not exerting itself, defeated Elgin 24 to 17. Sherry of Elgin is a good man and scored most of the points made by his team. Rutherford, Le Bas and Luse of Beatrice played up to their usual form, Luse getting all free throws on his chances.

A Great Game.

Omaha and Geneva played the great game of the afternoon, in which Geneva nearly overcame the lead established by Omaha in the first half by crawling up within two points. The Omaha players had the disadvantage of having to play on a small floor, but their goal shooting in the last half was poor and came nearly being the cause of putting them out of the race. Janda and Schneider are a great pair and put up the game of their lives, but Burkenroad of Omaha played the best game of the day, scoring twenty-six of the points made by the Omaha team. Lincoln, with a substitute team, ran away from Humboldt, making a record score of 56 to 8. Allen, Ager and Hugg for Lincoln formed a wonderful scoring machine, while Williamson of Humboldt was the one worthy man in the Humboldt lineup. University Place was again handicapped by the small floor, defeating Schuyler in a close game 13 to 6. Allen and Vifquain of University Place and McKenzie and Kadeleck of Schuyler were the stars.

The evening contests gave the large crowd two good games and one easy one. South Omaha and Central City had a hard-fought game. This contest showed the superiority of two tast, heady forwards of goal shooting penchants combined with excellent ability to work tegether, over a team that has good teamwork, but at the same time depends too much on long shots for goals. South Omaha won 37 to 12. Collins was at his best and did great playing for South Omaha. McDonald of Central City also played a good game. The Beatrice-Gothenburg rame furnished the amusement of the evening. Beatrice took the leading part, 44 to 7.

PERSHINGS MAY BE MILITIA PROPOSED CHANGES IN

UNIVERSITY RIFLE COMPANY IS UNDER CONSIDERATION AS PART OF NATIONAL GUARD.

Whether or not the Pershing Rifle company will be made a part of the SUMMER Nebraska National Guard is a question that is now under consideration by the state military department. It is being considered favorably by that department, according to Captain Yates, but the lack of adequate equipment may delay or even prevent the

If it is decided to make the Rifles a regular company of the militia, all uniforms and equipment will have to be furnished the men by the state department. As the Pershings drill once a week now, which is all that any guard company is required to drill, all that would be required of them would be that they enlist for a certain term of years and that they go to the annual camp of the state troops.

Officers and men would receive the pay of the militia while on duty; that is, while at camp or on special police duty.

How soon the matter will be definitely decided is not known. Richard Guthrie, captain of the company, said that it had been under consideration for some time, but as yet nothing has been decided. It is a question for the state department to decide. for the University military department is heartily in favor of the plan.

RULES FAVOR NEBRASKA

RECOMMENDATIONS OF COMMIT-TEE BRIGHTENS OUTLOOK.

BASEBALL IS ALLOWED

But Those Playing in Organized Leagues Will Not Be Permitted on College Teams.

Prospects for a Nebraska University baseball team brightened Friday when the changes recommended by the eligibility committee of the Missouri Valley conference were made public. If these changes are adopted at the next meeting of the Conference enough material will be rendered available in the University to make up a strong team.

Practice must begin immediately if any games are to be scheduled before the first of May. Kansas and Missouri have anticipated this report and have had squads at work on indoor practice for the past six weeks.

May Play on Home Team.

The chief change suggested is a modification of the rules to read:

"A student shall be ineligible to represent his college in athletic contests who engages in such contests as a representative of any athletic organization not connected with his college, except that he may participate in occasional games as a member of his home team."

Another is to strike out all of the clause regarding summer baseball which forces a student to refrain from playing summer baseball except on his home teams when no gate fee is

May Reinstate Offenders. The sentiment of the conference

"That most of the technical violations of the amateur rule in the past, for good reasons, may be overlooked and the offending parties reinstated.

"In order that this plan may be put into practice, it is further agreed that each conference athlete in order that he may become eligible for further inter-collegiate participation, shall sign a statement of his athletic experience, up to date, on a uniform conference blank.

"That it is understood that participation on baseball teams under the ruling of the National Commission, or on so-called outlaw teams, or teams of a similar professional character shall preclude reinstatement under this plan.

"That it is the sense of this conference that continuance of inter-collegiate athletics is contingent on a close adherence to the amateur prin-

"It is suggested that a student committee be elected by the students to concur with the faculty committee on matters of eligibility."

The method of reinstatement de cided upon was:

Committees May Co-operate. "That the signed statements of s given institution may first be submitted to its student committee, in order to give that body opportunity to co-operate with the conference committee in removing from its list names (Continued on page four.)
