BIG SQUAD PUT THROUGH GEN-ERAL WORKOUT.

Large Number of Candidates for Battery, Infield and Outfield, so Fast

Team Seems Probable.

Thirty-five men reported for the first two days of baseball practice, and with these as a starter it is thought that the squad will increase some until the varsity team is finally picked. The large number is due chiefly to the fact that Nebraska has not had a baseball team for two years. This gives all of the men an equal chance for the team, as most of them are of an unknown quantity. No attempt has yet been made to try any of the men out for respective positions, but the plan has been along the lines of a general workout. Each man is being given a chance to work out just as suits his fancy, and after about an hour or so the squad takes a run around the field and then hikes into the gym.

APPROPRIATION IS LEGAL

Supreme Court Decides Case Involving Proposed \$100,000 Medical Building.

The supreme court has declared legal the act of the legislature approbuilding on the campus of the medical college of the University of Nebraska

A decision written by Judge Letton upholds the law in every particular. The decision affirms the judgment of the district court of Lancaster county, which was that the law was valid. Dr. Samuel J. Stewart of Hastings appealed from the lower court to the supreme court. He alleged that the act was unconstitutional because it amends prior statutes without repealing them or referring to them. It was alleged that the act is class legislation because it will result in the construction of a medical college building to the exclusion of certain schools of medicine. It was also alleged that the act in effect amends an old statute which provides that all University buildings shall be within four miles of the state capitol building.

On this latter point the supreme court says the legislature can enlarge or relax any building limitations it may have established.
