# RALLY TODAY TO DISCUSS SINGLE TAX FACULTY AND ALUMNI SUPPORT MEASURE

### DEAN BESSEY, PRINCIPAL HUNTER, COACH STEIHM AND ANAN CONSIDER SINGLE TAY IDEA AS A MEASURE OF GREAT RAYMOND TO PRESENT PLAN AT CONVOCATION THIS MORNING

this morning at 11 o'clock in Memorial Hall the principles and advantages of the proposed single tax are to be brought forth in several short addresses

One of these is to be delivered by Dean Bessey, who has always paid particular attention to the welfare of the University as a whole and has made a study of student problems. Professor Hunter will present his view of the proposed measure as he sees it from the point of the Agricultural College of which he is head.

Coach Stiehm will represent the athletic faction of the University, and outline the benefits to various branches of sport to be gained through the single tax. Anan Raymond, '11. Law '13, is to speak on the phases of the plan as it appeals to a recent and active graduate. Thus the problem will be attacked from all sides and all students should be on hand to hear the discussion and make up their own minds as to the advisability of adopting the measure. It is the most marked step which has been attempted at Nebraska for some time and deserves the serious consideration of every student.

E. M. Rutledge- "The movement to place athletics and the Daily Nebraskan on a definite basis is a commendable thing.
