Senior Bonds for Payment of Class Debt Remain on Sale

To meet their small indebtedness this year the seniors voted bonds to the amount of \$75 to be issued among themselves. The bonds will be noninterest bearing notes at a par value of one dollar and are made redeemable on June 15 subject to the condition that the financial status of the treasury will admit of it. If it will not, then the funds in hand will be appropriated and apportioned pro rata among the seventy-five subscribers.

Under the present system of faculty supervision of class finances and in accordance with the findings of last year along this line it is a practical certainty that the money will be refunded in full on the date set.

The matter is being pushed hard and about thirty dollars have been subscribed to date. If the required amount is raised by Christmas the senior prom and hop will come off as usual.

The problem resolves itself into the question whether there are seventyfive seniors who will plank down a dollar now with its return assured or whether they would prefer throwing the prom and the hop into the discard and also meeting an assessment at the end of the year with no return.

Pan-Hel Alumnae Board **Wants Rules Printed** and Made Certain

The alumna board of the women's Pan-Hellenic Council met Monday at 5 o'clock in the faculty room of the administration building. While transacting business the committee made tea and served it with suitable accompaniments. An enjoyable social time was reported, as well as profitable results in the way of accomplishment.

What chiefly occupied the board at this meeting was the matter of formulating, with completeness, and in exact and unambiguous language-this practically for the first time since the Pan-Hellenic has existed—of the women's Pan-Hellenic rules. The latter have largely been handed down orally all these years, and discussions have been chronic regarding their interpretation or infringemen. Some of the rules were set down in printed or in type written form, but the phraseology was likely to be the chance phraseology of some meeting, and the language so far from explicit that the alumnae committee itself was not certain in all cases what the rules involved and what they did not. A step in advance was made this fall when some enterprising students placed the more important rules in printed form, in a way easy to handle and to read; but much was still left to oral agreement and much was still left ambiguous. These print ed rules, made by the students, and those existing earlier in typewritten form, were used by the committee as the basis for the new formulation which it expects to bring before the Pan-Hellenie Council.

The alumnae remarked that they expected to eliminate from their document the word "sorority" (this so long as the national women's Pan Hellenic refuses its sanction to the coinage) the objectionable "bid" for invite, or invitation, and the unacademic though convenienct "rushee." Their objection did not extend, the committee said, to the oral use of these words by any body who like them, but only to their appearance in printed documents associated in an official way with a uni-

Few changes in the rules themselves will be recommended to the chapters. The board expressed itself as content on the whole with the working of the rules this fall, the general sanity and quiet of the rushing season, and its curtailment of expenditures as compared with those made necessary last Success pared with those made necessary last year. The few complaints of infringements which reached the board largements which reached the board largely concerned minor details, and for most of them the lack of explicit wording in the rules seemed to be responsible. Hence the first task set itself by the committee was to set down in black and white, in exact language, the complete body of the Pan-Hellenic rules, thus doing away altogether with all reliance on oral agreement, or oral decisions concerning in terpretations.
