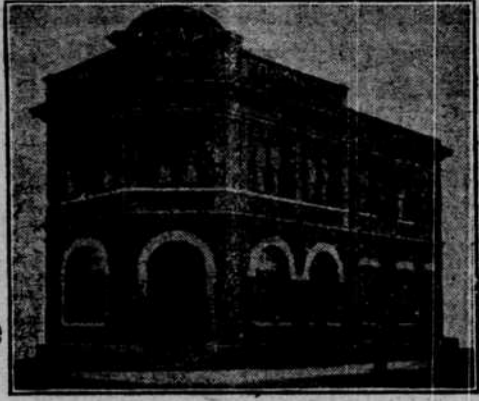

John Heapy's little girl is better. Jim Hagar is again able to be out. Milo Gilbert was shelling his corn Monday.

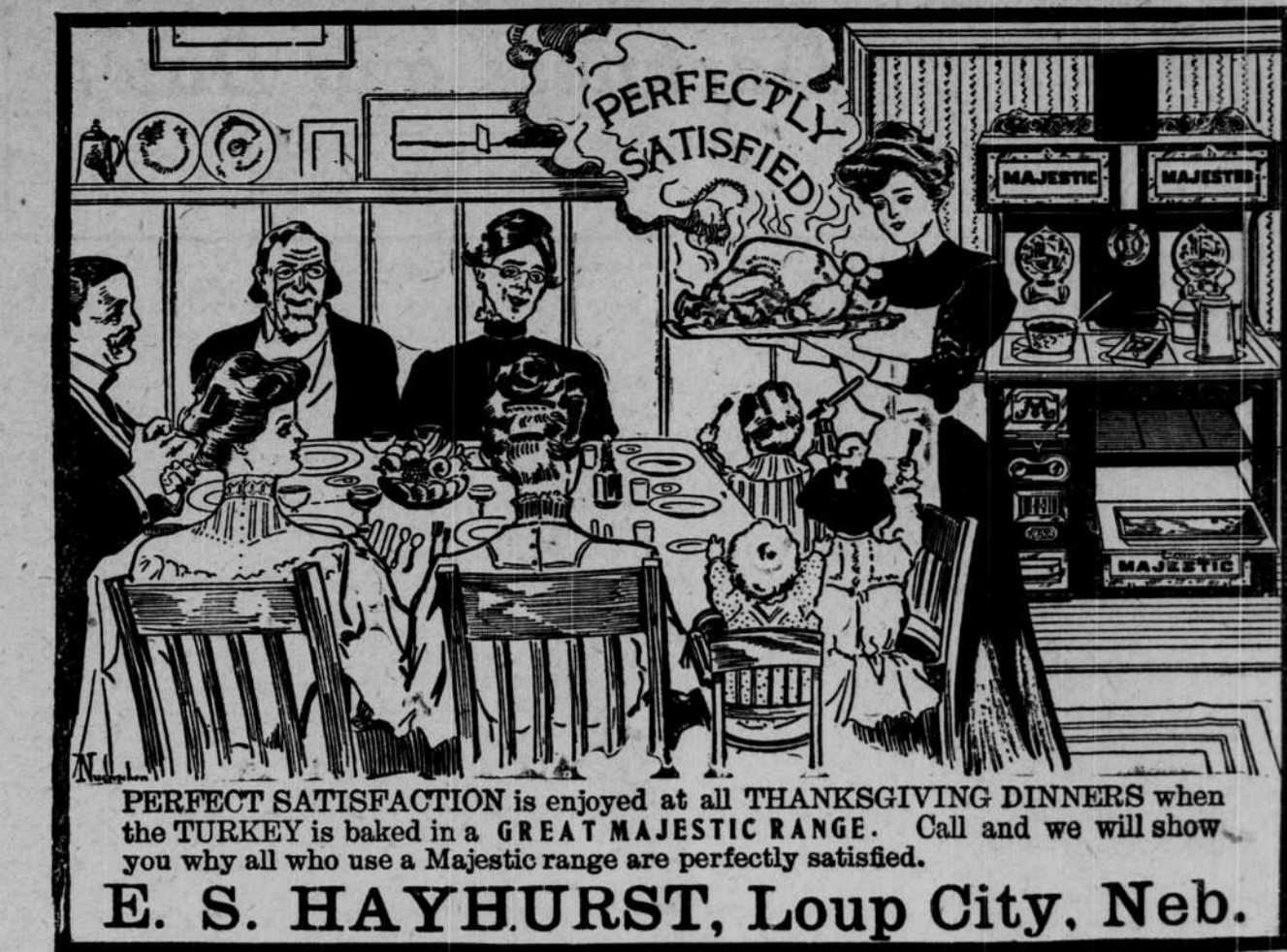
