 We received a pleasant call Tuesday from ex-Senator M. L. Fries of Arcadia. Mr. Fries admitted he was a candidate for governor at the hands of the republicans, provided the party put county option in its platform; otherwise he would not allow his name to go before the voters for that office. We admire Mr. Fries for the frankness of his position. He is uncompromisingly in favor of county option, and so states without any equivocation or evasion whatsoever. The Northwestern feels very favorably disposed toward Mr. Fries, whom it considers one of the ablest men in the state and well qualified in every particular to give the people an administration that would have the approval of all right-thinking men.

The longer Nebraska keeps such men as E. J. Burkett in the senate, the better and more favorably the state will be known and appreciated.

Congressman Norris, who is just now in the lime light as the man who put Joe Cannon to rout, has just cause for libel against the papers who are publishing supposed pictures of him. The variety and styles and awfulness is enough to drive him to drink.

The city election Tuesday passed off very quietly. The "wets" won by a majority of 66 votes, which was unexpected. There was no contest over any of the offices but that of city clerk. Peter Rowe winning over "Never Sweat" by a majority of 60, which had been a foregone conclusion from the first of the city campaign. The ticket elected is as follows: Mayor, G. F. Petersen; clerk, Peter Rowe; treasurer, L. Hansen; police judge, Geo. W. Hunter; city engineer, Lee Adamson; councilman, 1st ward, H. J. Swanson; councilman, 2nd ward, Wm. Criss. There was a big majority in favor of selling the city engine, engine house and two lots upon which the same is situated.

The U. S. supreme court rendered a decision the first of the week declaring unconstitutional the Nebraska law requiring railroads to build switches to all grain elevators along their tracks, upon request. Justice Holmes, in announcing this opinion, asserted that although the state possessed certain police powers and that railroads must fulfill the purposes for which their charters were granted, yet, he added, "railroads, like owners of property, have rights that are protected by the constitution." He held their property could not be taken without compensation as he said the law proposed to do in requiring the railroads to build switches to the elevators in question.

We have received a copy of H. R. 22067, introduced by Mr. Kinkaid in the lower house on March 29th, which will be found of interest to veterans of the War of the Rebellion, the Spanish American war or the Philippine insurrection, which reads as follows: "That any person who was honorably discharged from his last contract of service as an officer, soldier, sailor or marine in the army, navy, or marine corps of the United States, be considered to have been honorably discharged from all former similar contracts previously entered into by him; and the time he actually served in such army, navy or marine corps under his several contracts of service shall be deducted from the period of five years' residence and cultivation required by said homestead laws, but no patent shall issue to him until after he has resided upon, and cultivated his homestead for a period of at least one year after he shall have completed his improvements." That looks good to us and if passed means much to Uncle Sam's boys who have helped save the country.

Theodore Roosevelt has just at present sprung a sensation upon the entire world which makes other sensational matters look like the pale light of Luna by the side of the brightness of Old Sol. In a nutshell, Roosevelt wanted an audience with the pope, just as every other visitor to Rome desires to round out the number of interesting events in their foreign travels. The representative of the pope gave it out to the representative of Mr. Roosevelt that the pope would be pleased to give him audience, but intimated that it would be necessary for Mr. Roosevelt not to allow any such regrettable incident to transpire as that regarding ex-Vice President Fairbanks, or such audience would not be given. Roosevelt would not promise, and the publication of the matter has set the entire world ablaze. "The incident alluded to in the Fairbanks case was the recognition of the Methodist at Rome by Fairbanks, which caused the pope to refuse the latter audience. It is said Roosevelt had no arrangements to meet or address the Methodists, but stood on his rights to do as he pleased without restriction, hence called off the audience with the pope on his own motion. The incident will cause the widest comment of anything coming into the limelight of public life in the past decade, and will be discussed and pro and con in every village, and hamlet of the known world."

Gibbon Conference, April 14th

IN THE PRESBYTERIAN CHURCH
 The program for the country church conference which will be held in Gibbon in connection with the spring meeting of Kearney Presbytery has been completed. This Presbytery covers a large territory north of the Platte and has in it many country and small town churches. It is one of a series of such conferences now in progress throughout the middle west. Dr. Warren H. Wilson of New York city is the promoter of this movement and is a specialist on the problems of the country church. His thought is to assist the church to a place of larger service to the rural community. The report of the country life commission has been of great assistance in the agitation of the problem of the country church. 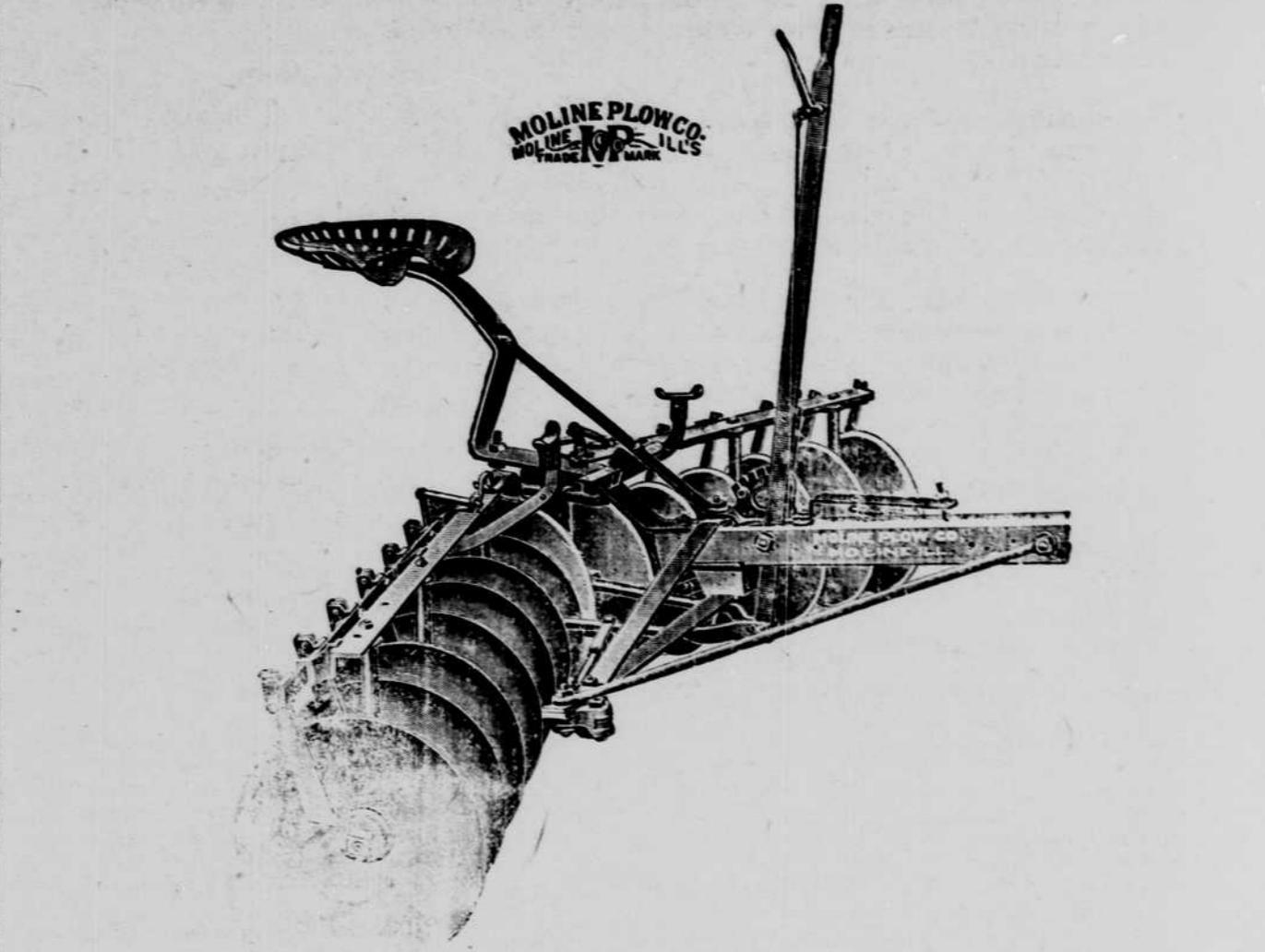

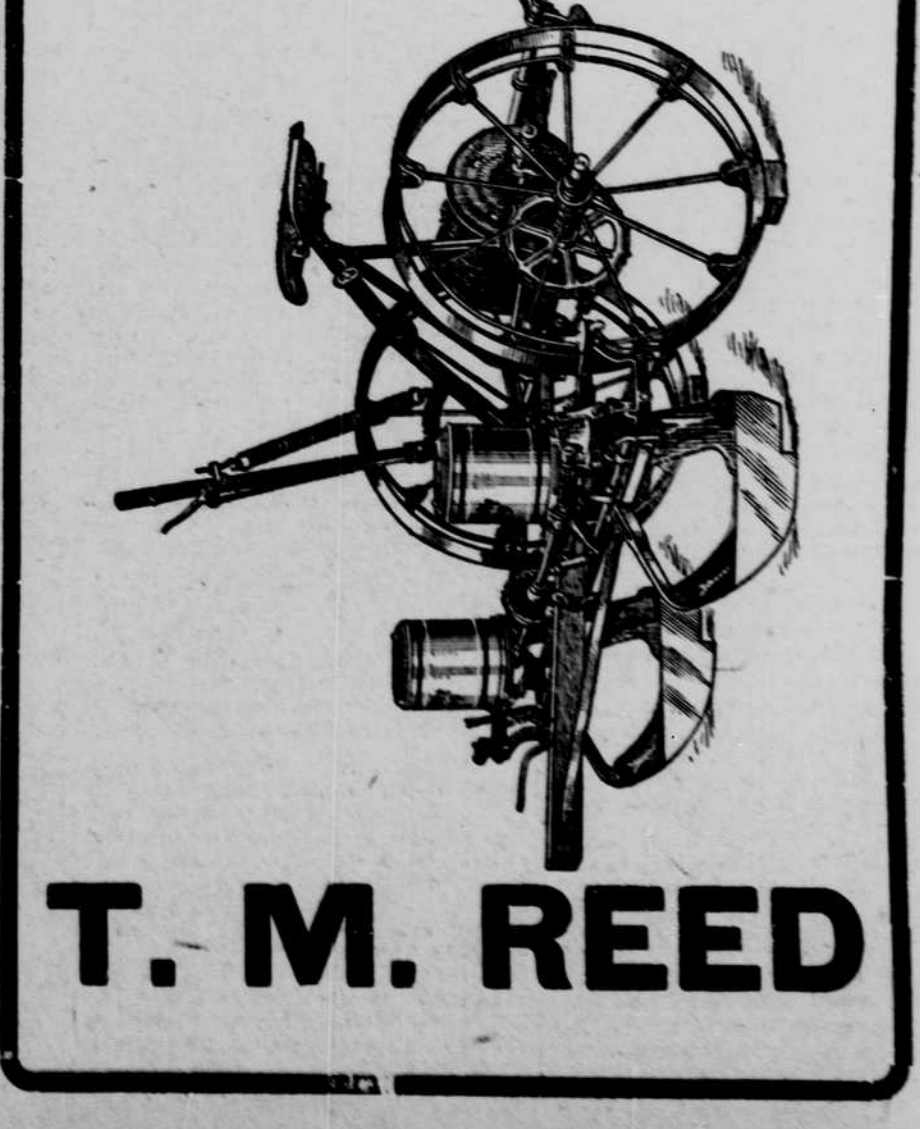
