The following resolution was passed unanimously by the executive committee of the Nebraska vice pres idential committee at a meeting in Omaha, Jan. 7, 1904:

Resolved, That we favor and recommend to the Republicans of the state an early state convention for the purpose of unequivocally pledging the support of the state to the candidacy of Theodore Roosevelt for president and of John L. Webster for vice president, and that we favor and recommend the selection as delegates to the National convention of such persons only as are known to be earnest ly and aggressively favorable to the candidacy both of President Roosevelt and of Mr. Webster.

The congressional investigation of the right of Apostle Smoot of the Mormon church to a seat in that august body is now on in all its glo. ry. Smoot is understood to be one of the strongest pillars of the Mormon faith, which claims polygamy as one of its fundamental principles, and yet he avers he is not a polygamist in practice or profession, nor has subscribed to any oath to that effect, as all good Mormons are supposed to be required to do. Either Smoot deals very sparingly with gilt-edged truthfulness or any old kind of an apostle is good enough for the Mormon church at the present stage of the game. This is what congress is trying to determine. Possibly present day Mormonism considers it no great sin to prevaricate in the interest of the church, on the hypothesis that it is none of the Gentile's business anyhow. But it is up to congress to show up the Smooty aspect of affairs if it can.
