

Last year the Y. W. C. A. and the Y. M. C. A. together with the faculty started a college settlement on 8th and W Streets. During the latter part of the school year socials, entertainments and receptions were held at different times, while in the evening, classes in the primary grades were taught.

While considerable was accomplished in this way, it was felt that organization was not complete enough to do the most that might be expected. It was decided by the student committee having this work in charge, that by all means a more thorough organization must be made and the work divided and put into the hands of different students who will be held responsible for the work.

It was suggested that this year arrangements should be made for both indoor and outdoor games and that certain students be appointed to direct them. Also that the entertainments of last year be again taken up, and if possible, given more frequently. More emphasis is to be laid upon the evening classes and it was unanimously decided that this work must be done systematically and continually. Last year teachers were changed every evening and as a consequence very little was accomplished in this line of the work, but now it has been proposed to put a certain student in the work who has the time to continue it for a time sufficiently long to allow him to make progress. If necessary a paid instructor, chosen from among the students, will be placed in charge.
