The Athletic board met in the office of the Physical Director last Saturday morning with all members present. The report of the committee to put the tennis association under the control of the board was adopted. The committee to revise the inter-collegiate rules was continued. The board proceeded to elect officers. The first formal ballot for baseball manager resulted, Denison 6, Ryons 4. By a motion Mr. Ryons was declared assistant manager. There were no contests for the other offices. E. A. Moore was elected track manager; R. D. Andreson assistant. Geo. Burgert was upon motion made manager of the tennis association. H. D. Landis will be his able assistant.



J. D. Denison, the manager of the University baseball team for '98, graduated from Upper Iowa University with the class of '93. While an undergraduate he twice represented his college in the Iowa state oratorical association. Mr. Denison always took an active part in college affairs—forensic, literary and otherwise. He was one of the best players on the N. I. U. baseball team, and captain of '93.

Mr. Denison entered U. of N. the fall of '96. He is a member of the '98 law class. Since coming here Mr. Denison has made an enviable record as a public speaker. Last year he represented Nebraska in the Kansas debate, quit the local oratorical contest with honors and was elected president of the state association. His election as baseball manager will silence faction; it will mean clean athletics and a strong team.



E. A. Moore, the track manager for '97-8, is a member of the senior class. He is thoroughly a University man. He is loyal to his class, a faithful worker in the Palladian society and an earnest supporter of athletics. He has sufficient ability and energy to put track athletics where it has never been heretofore. Like Mr. Denison he is the animated foe of "professionalism."
