You and each of you are hereby notified that on January 18, 1895, The Omaha National Bank of Omaha, Nebraska, as plaintiff, began an action against you and other defendants in the district court of Lancaster county, Nebraska, the object of which is to foreclose a certain mortgage on the following land in said county, to-wit:
