Sale of Timber Lands and Other Unallotted Lands and Surface of Segregated Coal and Asphalt Lands Belonging to the Choctaw and Chickasaw Indian Tribes in Eastern Oklahoma
by the
UNITED STATES GOVERNMENT

There will be offered for sale at public auction at certain railroad points in eastern Oklahoma, from October 15th, 1917, to October 31st, 1917, inclusive, approximately 400,800 acres of timber land, 50,200 acres of the surface of the segregated coal and asphalt land, and 500 acres of other unallotted land, all belonging to the Choctaw and Chickasaw Indian Nations in Oklahoma. The surface of the segregated coal and asphalt lands classified as suitable for town-site purposes, and the timber lands, will be offered for sale for not less than the appraised value. Land and timber will be sold together. The entire estate in the tribal timber lands and other unallotted lands will be sold except, however, that of the segregated coal and asphalt land area only the surface will be sold, the coal and asphalt therein or thereunder being reserved to the Choctaw and Chickasaw Nations, except where the descriptive circular specifically states that the coal and asphalt will be sold with the surface. The tribal land will be offered in various sized tracts but no person will be permitted to purchase more than 160 acres classified as agricultural land nor more than 640 acres classified as grazing land. No limitation is placed on the acreage of timber land which may be purchased by one person. Residence on land not required. Bids may be submitted in person or by agent with power of attorney, or by mail. Terms of sale of surface of segregated coal and asphalt lands, classified as agricultural or grazing lands, shall be cash, the successful bidder being required to pay 25 per cent of purchase price at time of sale and the balance within 15 days thereafter, or in case the successful bidder submitted his bid by mail, said balance must be paid within 15 days from date of notice. Terms of sale of surface of segregated coal and asphalt lands, classified as suitable for town-site purposes, shall be 25 per cent cash at time of sale, 25 per cent within one year, and balance within two years from date of sale. Terms of sale of tribal timber lands and other unallotted lands shall be 25 per cent cash at time of sale and balance in three equal annual installments of 25 per cent each, payable in one, two and three years, respectively from date of sale; the purchasers of any of the above mentioned lands to pay 5 per cent interest per annum on all deferred payments. Bids by mail must be accompanied by certified checks or bank drafts for 25 per cent of the amount of bids. Where houses or other improvements are located on the timber lands, or on the surface of the segregated coal and asphalt lands, the same will be sold with the timber land or the surface of the segregated coal and asphalt land as the case may be, said improvements to be paid for in full at time of sale, and except in case of the improvements within the segregated coal and asphalt area classified as agricultural or grazing land, shall not be sold for less than the appraised value. The right to reject any and all bids is reserved. Detailed information in regard to dates, places, conditions, and terms of sale, and including lists or circulars descriptive of the lands to be offered for sale, may be obtained free of cost from Mr. Gabe E. Parker, Superintendent for the Five Civilized Tribes, Muskogee, Oklahoma. Maps and plats may also be obtained from said Superintendent at a cost of from 25 cents to 50 cents each.

clothing; soap and soap powders; all engines and motors operated by steam, gas, electricity or other motive power and their accessories; metal and wood-working machinery; oil-well casing, oil-well drilling implements and machinery and the accessories thereof; steam boilers, turbines, condensers, pumps and accessories thereof; all electrical equipment; crucibles; emery, emery wheels, carborundum and all artificial abrasives; copper, including copper ignots, bars, rods, plates, sheets, tubes, wire, and scraps thereof; lead and white lead; tin, tin plate, tin cans and all articles containing tin; nickel, aluminum, zinc, plumbago and platinum; newspaper, print paper, wood pulp and cellulose; ash, spruce, walnut, mahogany, oak and birch woods; and industrial diamonds; shall not, on and after the 30th day of August in the year one thousand nine hundred and seventeen, be exported from, shipped from or taken out of the United States or its territorial possessions to Abyssinia, Afghanistan, Argentina, that portion of Belgium not occupied by the military forces of Germany or the colonies, possessions or protectorates of Belgium, Bolivia, Brazil, China, Chile, Columbia, Costa Rica, Cuba, Dominican Republic, Ecuador, Egypt, France, her colonies, possessions, or protectorates; Guatemala, Haiti, Honduras, Italy, her colonies, possessions, or protectorates; Great Britain, her colonies, possessions, or protectorates; Japan, Liberia, Mexico, Monaco, Montenegro, Morocco, Nepal, Nicaragua, the colonies, possessions, or protectorates of the Netherlands, Oman, Panama, Paraguay, Persia, Peru, Portugal, her colonies, possessions, or protectorates; Roumania, Russia, Salvador, San Marino, Serbia, Siam, Uruguay, Venezuela (excluding any portion of the foregoing occupied by the military forces of Germany or her allies), or any territory occupied by the military forces of the United States or by the nations associated with the United States in the war.

The regulations, orders, limitations, and exceptions prescribed will be administered by and under the authority of the exports administrative board from whom licenses in conformity with said regulations, orders, limitations, and exceptions, will issue.

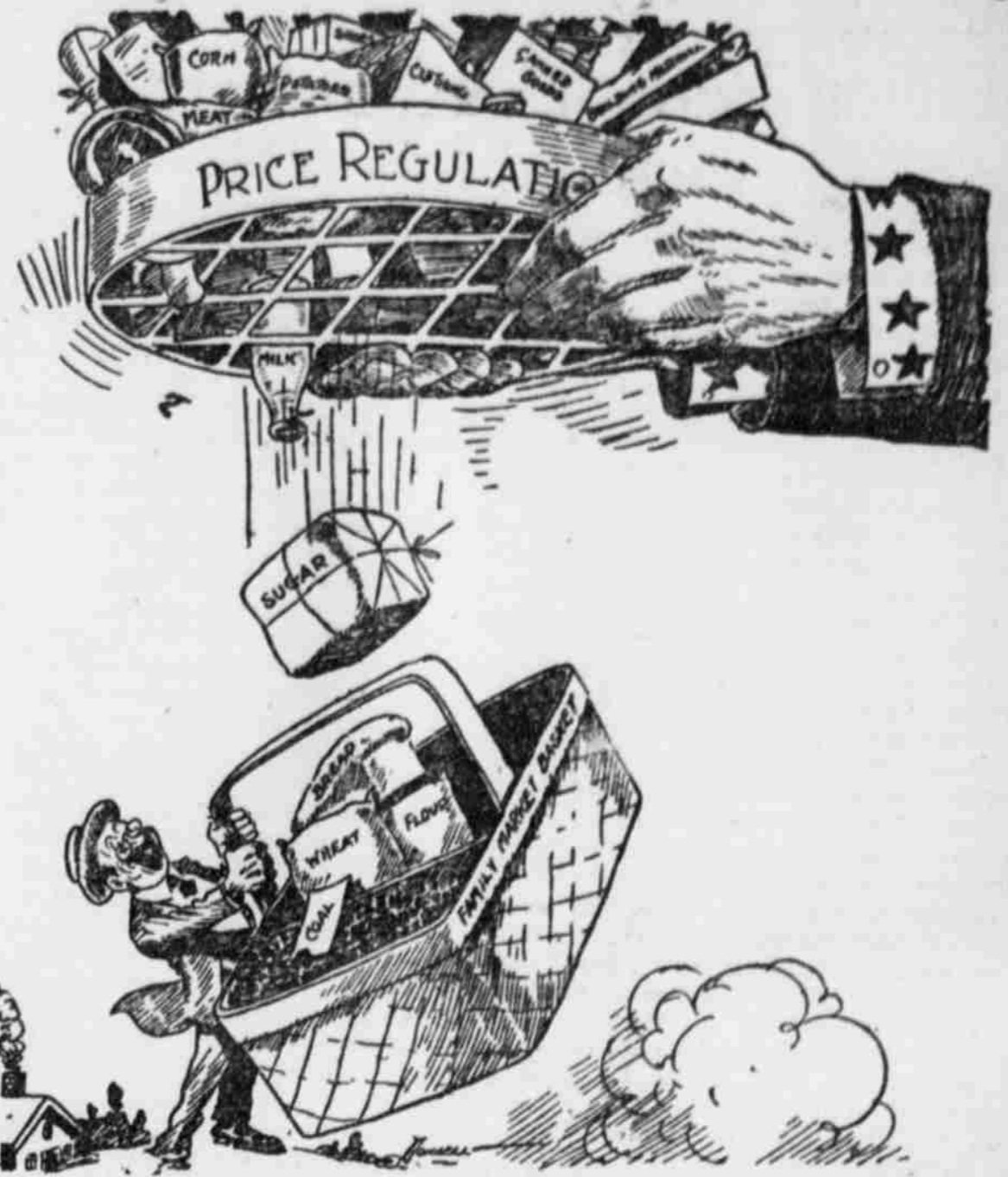

That we were right is shown by the recently uttered words of Mr. Bryan. He says, over his signature: "Before our nation enters a war

it is perfectly proper to discuss the wisdom of going to war, but the discussion is closed when congress acts. After that, no one should be permitted to cloak attacks upon his government or aid to the enemy under the claim that he is exercising freedom of speech. No sympathy, therefore, will be wasted upon those who have been arrested for unpatriotic utterances. They abuse free speech. And this applies to attacks on the

Allies as well as to attacks upon the United States. We can no more allow our Allies to be crushed than we can afford to be crushed ourselves. The defeat of our Allies would throw the whole burden of the war upon us. We must stand together and fight it through. There are only two sides to a war—every American must be on the Side of the United States." Mr. Bryan's attitude now is a lesson to many.—Havana (Cuba) Post.
