A written brief of a case is usually presented to the court before it comes to trial, to inform the justices of the issue to be decided. Krivosha said that he reads 100 briefs every month, 11 months of the year. Words paint pictures and this must be done quickly and properly or the idea will be lost, Krivosha said.

An oral argument follows in the courtroom after the brief has been read. These are usually presented to answer questions that weren't addressed in the brief. Krivosha said that if the court attacks a weak point in the case, a trial lawyer should acknowledge the weakness, but not attempt to defend the impossible. The most effective oral presentations are those that are limited to key issues, he said.
