Prices Very Favorable Livestock Receipts Heavy

Supplies of livestock at the local auction were heavy again this week as stockmen took advantage of the nice weather conditions and the favorable current prices on all classes of livestock. Buyers, too, were plentiful and the market showed a firm undertone and a brisk pace thruout. The quality of the offering, generally speaking was not as good as a week ago, and taking that fact into consideration, prices looked fully steady.

There were no fancy calves in the day's offering. One load of steer calves, averaging 370 pounds paid \$13.30, but the bulk of these cashed from \$12.00 to \$13.00. Heifer calves sold mostly from \$11.00 to \$11.80.

A good supply of yearlings were here. One load lot, averaging 630 pounds, sold at \$11.75 with a few smaller bunches reaching a little higher. Heifers placed mostly from \$10.00 to \$11.00.

A few two-year old steers sold around \$11.00 and supplies were rather limited in this class.

Fat cows were in good demand and the best sold here brot \$8.25 or better. Bulk of the cow offering ranged in price from \$7.00 to \$8.00. Bulls were strong in price with the bulk selling around \$9.00.

Another fine run of hogs showed up and the full supply found ready outlet at advanced prices. Handy weight butchers bulked at \$13.20 and \$13.25 and a large supply of these was here. Sows moved at prices ranging from \$12.50 to \$12.75.

Feeder pigs, of which there was an unusually heavy run, cashed as high, as \$15.40 with the bulk ranging in price from \$13.50 to \$14.50.

A few sheep and a sprinkling of horses and mules finished off the regular auction.

In conjunction with the regular livestock auction, several articles, donated by Holt County citizens, were sold and the receipts turned over to the American Red Cross. The complete report of these donations will be found elsewhere in this issue.
