1 or 2 eggs
1/4 cup corn syrup (or 1/4 to 1/2 cup sugar)
1/2 cup molasses
1/2 to 3/4 cup shortening
If you are short on any of these items, use the lesser amount of sugar by tablespoons. If syrup is used, beat in with molasses. Then add melted shortening.
1/2 cup boiling water
Add flour and boiling water alternately in two parts. Fill layer or sheet pan 1/2 full and bake 35-40 minutes at 350 degrees. Also bakes well in muffin tins. Fill tins 3/4 full and bake 24-30 minutes.
Serve with applesauce, cream or cottage cheese filling or topping, or hot lemon sauce topping.
