THE PAST

Under the date of January 21st, 1930, and recorded in Book 64, you will find the Articles of Incorporation for the Central Finance Corporation of Norfolk, Nebraska.

Reflecting the signs of the times, its beginning was small. The capital stock was \$25,200.00. Many of you people remember the years this state went through following the year 1930. There was drouth . . . bank holidays . . . depression.

Between the years 1930 and up to the year 1940 the corporation made progress. In 1940 the capital structure had grown to \$134,100.00. At that time the Company had offices in Norfolk; Neligh; O'Neill; Sioux City, Ia.; Columbus; Valentine; and Vermillion, South Dakota.

World War II caused considerable retrenchment. Since the personnel in the Neligh, Columbus, Valentine, Sioux City and Vermillion offices joined the armed forces, those offices were liquidated and the Norfolk and O'Neill offices remained in operation. After the war the Neligh branch was reopened and today the offices are located at Norfolk, Neligh and O'Neill.

THE PRESENT

As of 1950 the Central Finance Corporation employs a total of 18 people in its offices. Its present capital structure is \$318,827.21 and in 1949 the corporation handled approximately \$2,500,000.00 in business throughout this territory.

The Central Finance Corporation is a locally owned business. We pay our taxes in Nebraska, trade with Nebraskans. Our employees spend their wages in Nebraska. The policies of the company are made here. Our friends and neighbors are in Nebraska.
